EXECUTIVE SUMMARY:

Pursuant to County Code 10.03.040, the Sustainability & Solid Waste Program, which is part of the Department of Transportation and Development (DTD), administers the County's solid waste and waste management requirements, in part through management of the County's Integrated Solid Waste Collection System. This work includes an annual review of the production records of the seven collection companies, and the transfer station operator, that hold Board-approved solid waste collection and transfer franchises.

The purpose of the annual review is to ensure that solid waste collection and transfer services are provided to residents and businesses safely, cost-effectively, efficiently, and in a manner that supports the benefits of recovering materials from the system. The review is used to establish the fees charged for the variety of services the County requires its franchisees to offer and to ensure a fair return to the franchisees.

Solid Waste Commission Recommendation

The Solid Waste Commission, serving as the County's formal advisory body for managing the solid waste system, met on May 12, 2026 to discuss the annual review, the proposed fee increases, and review the option to establish an income-qualified residential reduced fee program. The Commission voted 3-0-4 (one vacancy, one absence, and two abstentions) to accept the review and recommend to the Board for consideration the proposed fee increases and to adopt an income-qualified residential reduced fee program.

June 2, 2026 Board Policy Session

On June 2, 2026, DTD staff presented a Policy Session to share the findings of the County's annual solid waste review and present the Solid Waste Commission's recommendations. The Board approved the fee increases and an income qualified

residential reduced fee program, effective July 1, 2026, as recommended by the Commission.

Whereas, the Sustainability and Solid Waste Program in the Department of Transportation and Development (the Program) is responsible for managing the County's Integrated Solid Waste Collection System; and

Whereas, pursuant to Clackamas County Code section 10.03.340, the Board has established uniform Waste Management Fees (WMFs) for solid waste collection services within different zones of the County and for transfer services at the Clackamas County Garbage and Recycling Transfer Station; and

Whereas, the Program conducts an annual review of the production records of the companies holding Board-approved solid waste collection and transfer franchises, which is used to make adjustments to the WMFs in order to ensure a fair return to the franchisees; and

Whereas, based on the annual review, the Program requested that the Solid Waste Commission (the Commission) recommend WMF adjustments to the Board; and

Whereas, the Commission, at a meeting on May 12, 2026, recommended that the WMFs be adjusted for a majority of the classes of residential and commercial can/cart service, for container collection service, for drop box service, for infectious waste, and for miscellaneous services in all fee zones, as set forth in Exhibit A to this order, and recommended that the WMFs be adjusted for a majority of the transfer services at the County's transfer station, as set forth in Exhibit B to this order; and

Whereas, the Board recognizes the importance of implementing a residential reduced fee program to support qualifying households; and

Whereas, operating costs such as labor, the rate per ton on disposed waste, and other costs related to collection are increasing effective July 1, 2026; and

Whereas, the Board, having considered the investment in facilities and equipment; the services of management; local wage scales; the concentration of collection service customers in the service area; methods and costs of storage, collection, transportation and disposal; the length of haul to disposal facilities; a reasonable return and operating margin for the owner(s) of the companies holding Board-approved solid waste collection and transfer franchises; the future service demands of the area or site which must be anticipated in equipment, facilities, personnel or land; extra charges for special pickup or pickups on days where service is not normally provided on a route; extra charges where the type of character of waste or solid waste, including but not limited to wastes with peculiarly offensive odors, requires special handling or service; extra charges for providing janitorial services on

the premises where service is provided; and extra costs for providing the opportunity to recycle under ORS chapters 459 and 459A, finds that the WMF adjustments recommended by the Commission are just, fair and reasonable to provide the required services to the public;

Section 1: The WMFs are adjusted as shown on Exhibit A and Exhibit B to this order.

Section 2: This order shall be effective on July 1, 2026.

Containers that have been compacted are charged 2.2 times the regular container fee for the zone.
Overweight compacted containers weighing over 500 pounds per cubic yard will be charged this fee plus disposal for the excess weight.
Container cleaning fee will be charged for containers needing cleaning more than 2 times in a 12 month period. The fee is the actual cost of cleaning.
Mileage fee applies to Distant Rural and Mountain Fee Zones when containers are located over 26 miles round trip from a disposal site if there are less than seven (7) containers picked up per collection route.
