AMENDMENT NO. 1 TO CONTRACT FOR SERVICES
(Amending Contract No. 2024-160)
Pursuant to Linn County Resolution & Order No. 2026-149

THIS AMENDMENT is made and entered into by and between the following parties:

LINN COUNTY, a political subdivision of the State of Oregon, of P.O. Box 100, Albany, Oregon, 97321 (the "County") and **CLACKAMAS COUNTY**, a political subdivision of the State of Oregon, acting by and through its CLACKAMAS County Juvenile Department, a department of CLACKAMAS County Government, (hereinafter referred to as "Clackamas").

The parties having executed a intergovernmental contract pursuant to Linn County Resolution and Order No. 2024-160, now hereby agree to amend said contract as follows:

1. The section entitled "**Term of Intergovernmental Agreement**" is amended to read as follows (additions are underlined and deletions are in strike-out):

This Agreement shall be effective and services required hereunder shall commence on July 1, ~~2024~~ 2026 and shall terminate on June 30, ~~2026~~ 2028, unless otherwise terminated or extended as provided herein.


Except as expressly amended above, all other terms and conditions of the original agreement are still in full force and effect. The Contractor certifies that the representations, warranties, and certifications contained in the original agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
