STATEMENT OF RIGHTS

- 1. Prior to the Hearing. You have the right to make the following requests:
 - (A) You can request the opportunity to review public records and talk to County Staff about the violations or request a subpoena for that purpose if the County does not allow you to do so.
 - (B) You can request that the Hearings Officer postpone the hearing for good cause by writing the Hearings Officer at least 7 calendar days prior to the scheduled hearing date.
 - (C) You can request that the Hearings Officer decide the matter based exclusively on written materials from the parties or conduct the hearing by phone.
- 2. Procedure. The hearing will be governed by general rules of procedure designed to allow you to hear and confront the evidence against you, and for you to present evidence favorable to you. You are not required to present any evidence; the burden is on the County to establish by a preponderance of evidence that a violation exists or existed. Either party may, at their own expense, obtain an attorney, to represent that at the hearing. If you wish to be represented by an attorney, they need only notify the County and the Hearings Officer in writing of their intent to appear on your behalf. The County will present evidence first, and then you may question that evidence. You may then present your own evidence, if you wish, and the County may question your evidence. Testimony by witnesses is evidence. The Hearings Officer may inquire into any facts that are relevant to the hearing and may question parties or witnesses about the case. Evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their serious affairs shall be admissible.
- 3. Record of Proceedings. An audio record will be made of the proceedings when a hearing is conducted. The audio record is available through the Clackamas County Code Enforcement Section and is available to you upon request.
- 4. Hearings Officer. The Hearings Officer is an independent contractor paid by the County to conduct hearings and render decisions. He/she is not a County employee. His/her function is to preside over the hearing, make a record of proceedings, consider admissible evidence and interpret and apply the law. After the hearing is closed, the Hearings Officer will enter written findings of fact, conclusions of law and any Order deemed proper. If a violation is proven, then the Order may include civil penalties, fines, administrative fees, or may require the respondent to take certain actions, or refrain from certain actions. An Order issued by the Hearings Officer may be a final order or a continuing order. The Hearings Officer Order is the final decision of the County, and may be appealed pursuant to Oregon Law. - <u>5. Right to Recess.</u> If, during the course of the hearing, the Respondent or the County requests a recess or postponement, or additional time to present crucial evidence, the Hearings Officer may allow a continuance of the hearing for good cause. The Respondent may also request that the proceedings be continued after the end of the hearing if the Respondent determines that additional evidence should be brought to the attention of the Hearings Officer.
- **<u>6. Right to Appeal.</u>** The Final Order of the Hearings Officer shall set forth the right of the respondent to appeal any adverse Order. Appeal may be taken pursuant to Section 2.07.130 of the Clackamas County Hearing Officer Code, and Oregon Revised Statute 34.010-34.100. If appeal is taken, the appellant is responsible for all costs of appeal including preparation of transcript.

COMPLAINT AND REQUEST FOR HEARING

I, Andrea Hall, Senior Code Enforcement Specialist for Clackamas County, allege the following:

1.

Respondents Sarah Araujo's mailing address is: 785 N Ivy St., Canby, OR 97013.

2.

The Respondent owns the address or location of the violation(s) of law alleged in this Complaint which is 785 N Ivy St., Canby, OR 97013, also known as T3S, R1E, Section 33BD, Tax Lot 6200, and is located in the City of Canby in Clackamas County, Oregon. This property is zoned R1 Low Density.

3.

On or about the 23rd day of October, 2023 and January 19, 2024 the Respondent violated the following laws, in the following ways:

a. Clackamas County Building Code Section 9.02.040(E) for failing to obtain a permit and approved final inspection for the replacement of roof rafters in a single family dwelling.
 This violation is a Priority 1 violation pursuant to the Clackamas County Violation

Priorities.

The Department initiating this procedure is the Code Enforcement Section of the Department of Transportation and Development.

5.

Notice of the violation was given to Respondent in the following manner: A Violation Notice dated October 23, 2023 and Citation and Complaint number 2300292 dated January 22, 2024. A copy of the notice document is attached to this Complaint as Exhibits D and E, and incorporated by this reference.

6.

Based on these allegations, petitioner requests that a hearing be set in this matter.

Petitioner seeks an Order from the Hearings Officer granting the following relief:

- 1. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondent to immediately abate the violations and bring the property at issue into compliance with all laws, and permanently enjoining Respondent from violating these laws in the future;
- 2. Pursuant to Clackamas County Code Section 2.07.090, imposing a civil penalty against Respondent for each violation, within the range established by the Board of County Commissioners. Said range for the Priority 1 violation being \$750.00 to \$1000.00 per occurrence as provided by Appendix B to the Clackamas County Code;
 - 3. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondent to pay an administrative compliance fee as provided by Appendix A to the Clackamas County Code; and
 - 4. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondent to reimburse the County for any expense the County may incur in collection of any penalties,

fines or fees that may be imposed:

5. Ordering any other relief deemed reasonably necessary to correct the violations.

History of Events and Exhibits:

October 4, 2023 In response to a complaint, an alleged letter was mailed to the Respondent Exhibit A alleging that an addition to the back of the house may have been constructed

without the benefit of permits or inspections.

October 9, 2023 In an email to the County, the Respondent indicated there was no addition Exhibit B or remodel to the house but they had repaired the roof which required the

or remodel to the house but they had repaired the roof which required the replacement of wood that was rotten. The County replied and asked if the rafters had been altered to increase the ceiling height in the back part of the

house.

October 10, 2023 After the Respondent emailed and stated that they had removed drooping Exhibit C rotting rafters and replaced them with new, wider rafters the County sent a

rotting rafters and replaced them with new, wider rafters the County sent a message to Permit Technician Shirley Cass-Crosby to determine if a building permit would be required for the work done to the Respondent's home. The answer was that a permit would be required and the Respondent would also need to submit an evaluation letter from an architect or engineer along

with the drawing.

October 23, 2023 A violation notice was mailed to the property owner with a deadline of Exhibit D. November 30, 2023 to submit a building permit application to the

November 30, 2023 to submit a building permit application to the Clackamas County Building Codes Division. The permit was to have an

approved final inspection within 45 days of the date the permit was issued.

January 22, 2024 After a review of County records revealed that a building permit application had not been submitted to the Building Department, citation number

had not been submitted to the Building Department, citation number 2300292 was issued in the amount of \$500.00. The citation was sent first class mail and was not returned to the County, the citation remains unpaid.

May 14, 2025

After a review of County records revealed that a building permit had not been issued to the Building Department, the matter was referred to the Clackamas County Code Enforcement Hearings Officer.

If the Hearings Officer affirms the County's position that a violation of Clackamas County Building Code exists on the subject property, the County would request a Continuing Order be issued requiring the Respondent to submit a building permit application including technically complete plans and propriate fees for the roof repair and new rafters to the Building Department within 45 days of the date of the Order. Requests for additional information must be responded to within 10 days from the date of the request. The permit must have the fees paid in full within ten days of being notified the permit is ready and all inspections should be scheduled so that final inspections may be obtained not later than 45 days of the date of the permit being issued

The County will submit a timely Post Hearing Status Report. The report will be sent to the Compliance Hearings Officer and to the Respondent. The report may include the following recommendations:

- Waive citation 2300292 as the County is seeking civil penalties.
- o The imposition of civil penalties of up to \$1000.00
- The Administrative Compliance Fee of \$75 per month to be imposed from October 2023 through today which is \$1350.00, however the County is requesting a reduced Administrative Compliance Fee of \$150.00 as a reasonable estimate of the cost of this enforcement matter.
- If the violations are not abated the County may request authorization for further enforcement action including proceeding to Circuit Court.
- The County requests the Hearing's Officer to permanently enjoin the Respondent from violating these laws in the future.

- Administrative Compliance Fees. It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. An administration compliance fee of \$75 will now be assessed monthly until the violations are abated.
- 2. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, and (2) referral of this matter to the County Code Enforcement Compliance Hearings Officer.
- 3. Request for a Hearing: If you dispute the existence of the violations described in the enclosed letter you may request a hearing before the Hearings Officer by sending a written request for a hearing, including your name and address to: Code Enforcement Section, 150 Beavercreek Rd., Oregon City, OR 97045, or at codeenforcement@clackamas.us.
- 4. **Potential Fines and Penalties:** The Clackamas County Code provides for Citation fine amounts of up to \$500 and additional civil penalties imposed by the Hearings Officer of up to \$3,500 for each day the County verifies the noncompliance. Fine amounts and civil penalties may be assessed for each cited violation and may be assessed separately against each named party. In addition, the Hearings Officer may order the violation to be abated by the County at the expense of the property owner(s) and responsible parties.
- 5. Voluntary Compliance: Clackamas County encourages voluntary compliance with code violations to support a safe and healthy community for all. Please note that when a property owner works cooperatively with the County to resolve a confirmed code enforcement violation, the County may in its discretion waive all or part of the \$75 per month administrative fee.
