EXECUTIVE SUMMARY: Clackamas Health Centers has an existing lease agreement with Gladstone School District for the purpose of providing an on-site primary care clinic and pediatric dental clinic located at the Gladstone Center for Children and Families (GCCF). These on-site services ensure patients have their healthcare needs met at a center open to families living in the community.

Lease Amendment #1 will allow for the continuation of existing healthcare services at the GCCF location.
