EXECUTIVE SUMMARY: This new tanker truck will be procured under State Contract PA4663 and will replace the chassis of a 2014 Freightliner Tanker Truck. The truck WES currently owns was damaged by attempted theft and vandalism in March 2025 thus is no longer serviceable. A replacement Freightliner chassis has been identified and is readily available at a dealership. This new chassis will be paired with the refurbished stainless-steel tank salvaged from the current vehicle. The new tanker truck will be configured to match the specifications and equipment of the vehicle it replaces. Because the chassis is currently available and requires no significant frame or equipment modifications, the build is expected to be completed within a few months. This represents significant time savings compared to the nine to twelve months or longer typically required for a new chassis order.

RECOMMENDATION: Staff recommend that the Board of County Commissioners of Clackamas County, acting as the governing body of Water Environment Services, approve a Board Order authorizing the purchase and configuration of a 2025 Freightliner

Whereas, the Clackamas County Board of County Commissioners, acting as the governing body of Water Environment Services, an intergovernmental entity formed pursuant to ORS Chapter 190 (the "Board") has authority to sign all contracts and any amendments or renewals of the same;

Whereas, Oregon Revised Statutes ("ORS") Chapter 279A.200-220 and Local Contract Review Board Rule C-046-0400 permit Water Environment Services to purchase goods using a cooperative procurement;

Whereas, State of Oregon established a Cooperative Contract # PA 4663 with PTG Oregon, LLC doing business as Premier Truck Group of Portland for the purchase of fleet vehicles ("State Cooperative Contract");

Whereas, Water Environment Services desires to purchase one (1) 2025 Freightliner 114SD Plus truck ("Freightliner Truck") through the State Cooperative Contract for a total contract price of \$213,878.00;

Whereas, the Clackamas County Department of Finance requests authority to utilize the State Cooperative Contract to purchase the Freightliner Truck by issuance of a purchase order ("PO");

Whereas, a PO is issued directly through the Department of Finance's management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners resolves as follows:

1. The requested use of the State Cooperative Contract to purchase the Freightliner Truck in the amount of \$213,878.00 is hereby approved; and
2. The Clackamas County Department of Finance is hereby delegated limited authority to issue a PO to purchase the Freightliner Truck using the State Cooperative Contract.
