EXECUTIVE SUMMARY: The Social Services Division of the Health, Housing and Human Services Department requests approval of Amendment #02 to an Intergovernmental Agreement with the City of Sandy to increase Mt Hood Express operations and maintenance funds.

The amendment will provide an additional \$100,000 in funding to the agreement to address necessary and unforeseen vehicle repair costs, which are essential to maintaining safe and reliable operation of the M. Hood Express transit services. These repairs are beyond the scope of the routine preventive maintenance initially funded under the agreement. The original agreement provides funding for preventative maintenance and operations for Mt. Hood Express.

Total agreement value increased to \$241,435. No County General Funds are involved.

RECOMMENDATION: Staff respectfully requests that the Board of County Commissioners approve Amendment #02 (11851) and authorize Chair Roberts or his designee to sign on behalf of Clackamas County.

AMENDMENT #2 TO THE INTERGOVERNMENTAL AGREEMENT WITH CITY OF SANDY FOR MT. HOOD EXPRESS OPERATIONS SERVICES H3S Contract #11851

This Amendment #2 is entered into between **City of Sandy** ("Agency") and Clackamas County ("County") and shall become part of the Intergovernmental Agreement documents entered into between both parties on **October 3**, **2024** ("Agreement").

The Purpose of this Amendment #2 is to make the following changes to the Agreement

I. Section 3. Consideration is hereby amended as follows:

The County agrees to pay Agency, from available and authorized funds, an additional sum not to exceed **One Hundred Thousand Dollars (\$100,000.00**) to fund necessary and unanticipated vehicle repairs and to accomplish the Work required by the Agreement, as further described in Exhibit A. Payments will be in accordance with the terms and conditions of the Agreement. A Cost Estimate Breakdown for this increase is hereby attached as **Exhibit B**. The maximum compensation authorized under this Agreement is \$241,435.00.
