**EXECUTIVE SUMMARY:** In accordance with County Code Chapter 8.05 and relevant Oregon Revised Statutes, the County licenses social gaming through an annually renewable licensure of social gaming conducted by charitable, fraternal, and religious organizations. Social gaming is any game, other than a lottery, between players in a private business, private club, or place of public accommodation with no house player, bank, or odds, and no house income from the operation of the social game.

Estacada Moose Lodge #333 has properly applied for a social games license, and the Sheriff's Office has issued their comments in the attached. Estacada Moose Lodge #333 is an Oregon nonprofit corporation which has existed since 1979 and operates under the auspices of their national organization, which has been issued a determination letter by the Internal Revenue Service as a 501(c)8 nonprofit fraternal organization.

Estacada Moose Lodge #333 meets the requirements under County Code and the relevant Oregon Revised Statutes for a Social Games License, and the Sheriff's Office comments indicate no reason to deny the application. Staff are not aware of any objection to the application.

**RECOMMENDATION:** Staff recommends the Board approve the Social Games License for Estacada Moose Lodge #333.
