EXECUTIVE SUMMARY: On behalf of the Housing and Community Development Division (HCDD), the Health, Housing & Human Services Department requests approval of an Amendment (11632) with YKC Hospitality, LLC to provide 41 on-call hotel rooms to be used as temporary housing.

This amendment will increase the room capacity from 25 rooms to 41 rooms and extend the agreement for an additional year. These rooms will serve multiple county purposes, including, but not limited to, temporary housing for homeless families and individuals, as well as housing to respond to the impacts of natural disasters, emergency events, or other situations wherein Clackamas County residents need temporary housing. At the same time, partner agencies assist them in obtaining permanent housing.

Program participants sheltering in these rooms receive supportive services through The Father's Heart Street Ministries. Services include but are not limited to, case management, individualized resource referral and connection, facilitating conflict resolution between hotel owners/management and program participants, and housing navigation assistance. Program participants are also connected to additional services and an ongoing rental subsidy to facilitate their placement into permanent supportive housing.

Funding for this amendment is provided through Supportive Housing Services Funds. No General Funds are involved.

AMENDMENT #1 TO THE CONTRACT DOCUMENTS WITH YKC HOSPITALITY LLC FOR MOTEL/HOTEL SERVICES Contract #11632

This Amendment #1 is entered into between YKC Hospitality, LLC ("Contractor") and Clackamas County ("County") and shall become part of the Contract documents entered into between both parties on May 16, 2024 ("Contract").

The Purpose of this Amendment #1 is to make the following changes to the Contract:

1. ARTICLE I, Section 1. **Effective Date and Duration** is hereby amended as follows:

The Contract termination date is hereby changed from June 30, 2025, to June 30, 2026.

2. ARTICLE II, Scope of Work is hereby deleted in its entirety and replaced with the following:

Unless this Contract is otherwise terminated according to its terms, County will purchase, and Contractor shall provide, 40 hotel rooms and an additional suite room on an on-call or as-needed basis for the one-year term of this Contract (for a total of 41 rooms). Because the exact number of on-call rooms, if any, County may need is unknown, nothing herein shall be construed as a promise by County to purchase all 40 on-call hotel rooms and the additional suite.

Contractor will provide the hotel rooms as further detailed in the Scope of Work attached and hereby incorporated by reference as Exhibit "A."

This Contract consists of the following documents which are listed in descending order of precedence and are attached incorporated by reference: This Contract and Exhibit A.

- **3.** ARTICLE III, Compensation Section 1, Payment. is hereby amended as follows:
 - 1. **Payment**. In consideration for Contractor providing on-call motel rooms during the period of July 1, 2025 through June 30, 2026, the County may pay Contractor, from available and authorized funds, an amount not to exceed \$1,200,625.00. Because this Contract is on an on-call or as-needed basis, and the exact number of rooms required by County, if any, is unknown, nothing herein shall be construed as a promise to pay Contractor the entire \$1,200,625.00 authorized under this Amendment #1. The total compensation authorized, including all possible damages under Article IV, Section 10, under this Amendment #1 shall not exceed \$1,200,625.00. The total Contract consideration shall not exceed \$2,448,125.00.
