If the measure is not approved, new marijuana production, processing, and wholesaling businesses will be allowed to operate within the City, as authorized under the Estacada Municipal Code. This measure was referred to the voters by the Estacada City Council.

**EXPLANATORY STATEMENT**

The City of Estacada currently allows for marijuana production, processing, wholesaling, and retailing businesses to operate as conditional uses within the City. State law allows for a city council to ban these types of businesses, if the ban is approved by the city's voters. The Estacada City Council has adopted a local ban on new marijuana processing, production, and wholesaling business from operating within the City, and is referring the ballot measure to the voters for approval.

If the measure is approved, existing marijuana processing, production, and wholesaling businesses may continue to operate within the City. New marijuana processing, production, or wholesaling businesses will not be allowed to come in. The ban will not have any effect on marijuana retailing businesses or dispensaries, which will be allowed to operate within the City as authorized in the Estacada Municipal Code.

If this measure is approved, the ban will take effect on the date the election results are certified.
