**EXECUTIVE SUMMARY:**

The Clackamas River Basin Council (CRBC) is partnering with County Parks, Tourism, and Long-Range Planning, as well as Oregon State Parks and the US Forest Service, to install indigenous artwork along the Clackamas River. They have worked with an artist from the Confederated Tribes of the Grande Ronde to produce a 9 ft tall steel sculpture on a 2' diameter base, entitled "Chief of the Salmon" to be installed, along with an accompanying interpretive sign, at Barton Park near the boat launch area. Because this portion of Barton Park is in the floodplain, CRBC was required to obtain a Floodplain Development Permit, and apply for a Principal River Conservation Area Review. These permits require the signature of the property owner.

**RECOMMENDATION:** Staff respectfully recommends the Board of County Commissioners authorize the Chair to sign these two permits as property owner.
