

Appointed Boards and Commissions (ABCs) Recommendation

The District Advisory Committee (DAC), staffed by the North Clackamas Parks and Recreation District (NCPRD), currently has three vacancies on their committee, two resulting from term expirations and one due to a resignation. The committee is composed of eleven members, each serving a four-year term.

Recruitment was open to the public from March 31, 2025, through May 31, 2025. The recruitment effort included outreach via press releases, Facebook, Nextdoor, the NCPRD website, and the county website. A total of six applications were received during this period. Of those, three applicants are being recommended for appointment—two as new members and one as a reappointment.
