Amendment Value is \$134,465.35 for 3 months. Total Agreement Value is \$990,604.65 for 27 months. Funding is through the Oregon Health Plan. No County General Funds are involved.**

**EXECUTIVE SUMMARY:** The Behavioral Health Division (BHD) of the Health, Housing, and Human Services Department requests the approval of Amendment #01 to a revenue agreement with Trillium Community Health Plan, Inc. (Trillium) for the funding of certain behavioral health services. This Agreement provides the funds for Behavioral Health Mobile Crisis, Choice Care Coordination, Wraparound Care Coordination, Peer Services, and administrative support to ensure compliance with the Agreement.

As one of the region's Coordinated Care Organizations (CCOs), Trillium is obligated under the terms of its contract with the Oregon Health Authority (OHA) to coordinate its services with local mental health and public health authorities in its service area. BHD assists Trillium in achieving its performance-based incentive metrics. The revenue received by BHD is based on the number of plan members and established service rates.

In 2025, Clackamas County averaged 9,614 Trillium Community Health Plan members, an increase of 1,096 members from 2024.

This Amendment #01, effective January 1 through March 31, 2026, adds \$134,465.35 for the additional months of service. The maximum agreement value is increased to \$990,604.65 for 27 months.

## AMENDMENT TO BEHAVIORAL HEALTH SERVICES AGREEMENT

### TRILLIUM COMMUNITY HEALTH PLAN AND CLACKAMAS COUNTY

This Amendment to Behavioral Health Services Agreement ("Amendment") is made as of this September 29, 2025, by and between Clackamas County, Oregon, a municipal corporation ("County" or "Vendor" or "Provider") and Trillium Community Health Plan, Inc. an affiliate of Centene Management Company, LLC ("Trillium" or "Health Plan") (each a "Party") and collectively the "Parties" with reference to the following facts:

- A. County and Health Plan entered into a Behavioral Health Services Agreement effective January 1, 2024 which may have been amended in accordance with its terms (the "Agreement");
- B. County and Health Plan desire to modify certain terms and conditions contained in the Agreement as provided in this Amendment;

NOW, THEREFORE, in consideration of the mutual promises, covenants, agreements and other undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Definitions: Defined terms used in this Amendment shall have the same meaning as in the Agreement unless otherwise specifically defined herein.
2. Section 22. Term and Termination: The term of this Behavioral Health Services Agreement is hereby extended for 3 months. The term end date is changed from December 31, 2025 to March 31, 2026.
3. Health Plan will compensate County an additional \$134,465.35 for this extended 3 month term.
4. Exhibit B-5 To Delegated Service Agreement Choice Care Coordination Services, section A. Choice Care Coordination is hereby updated to add the following bullet point:

Provide personnel and personnel-related expenses associated with the delivery of care and system coordination services to support primarily older adults with severe and persistent mental illness (SPMI) in Clackamas County.

Funds may also be spent on peer-delivered services to SPMI older adults.

Except as amended and modified by this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect. This Amendment may not be modified except in writing signed by both parties hereto. This Amendment, the Agreement, together with its attachments, as previously amended in each case, constitute the entire agreement of the parties with respect to the subject matter contained therein and supersede any and all prior or contemporaneous agreements between the parties, whether oral or written, concerning the subject matter contained herein.
