Attached is my testimony for the Clackamas County Sheriff's Office budget hearing today.

Good morning, Chairperson and County Commissioners. Thank you for the opportunity to speak today. My name is Jamie Pryde. I'm here not only as someone directly affected by the recent layoffs at the sheriff's office, but also as a resident of Clackamas County and a public servant who has proudly worked to make our community safer through volunteering with the Multnomah County Sheriff's Office, conducting research at the Oregon State Hospital about identifying and treating survivors of human trafficking, domestic violence, and sexual assault, and my time at the school of Criminology and Criminal Justice at Portland State University during my undergraduate and graduate careers.

Due to the ongoing budget negotiations, my accepted job offer as a Crime Analyst was rescinded. I had accepted this position, left previous employment, and would have begun my career as a Crime Analyst with the sheriff's office this week. This isn't just about a job — it's about a function that saves lives, helps prioritize limited law enforcement resources, and prevents crime before it happens. There is a reason Clackamas County has had the lowest crime rates per 1,000 people in 2022, 2023, and 2024 compared to the most populated counties in Oregon. This is due to the continued investment into public safety, so we are able to identify and address problems before they arise. The continued investment into a fully staffed sheriff's office is critical.

As a Crime Analyst, I use data to identify crime trends, target hotspots, and support investigations. I am responsible for providing strategic, administrative, and tactical analyses to every division within the Sheriff's Office. Furthermore, I research best practices, study crime activity and patterns, and assist in the development of analytical reports and evidence-based operations. My work helps deputies be in the right place at the right time, ensures taxpayer dollars are spent wisely, and supports policy decisions with hard empirical evidence — not guesswork.

With fewer analysts, the sheriff's office loses a vital lens into the patterns and trends that guide patrol strategy, investigations, and community outreach. It becomes harder to solve and prevent crimes, which ultimately increases costs — financially and socially.

Investing in a fully staffed sheriff's office isn't just about restoring one position — it's about maintaining a proactive, smart, and cost-effective approach to public safety. The return on investment is measurable: in reduced crime, safer neighborhoods, and efficient use of public funds.

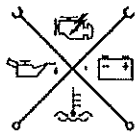
