REQUEST: Approval of proposed committee membership to review findings of the Best Practice Governance Implementation Team.

BACKGROUND: In February 2026, the Best Practice Governance Implementation Team presented its findings to the Board of County Commissioners (BCC). The team gathered and analyzed data from all Oregon Counties, as well as counties of similar size throughout the nation. The areas reviewed included:

- Full-time or part-time commission structure;
- Elected or appointed chair;
- District-based or at-large representation;
- Partisan or nonpartisan elections, and;
- Term limits or other eligibility requirements.

Following discussion of the findings, the BCC directed staff to establish a committee to further review the data and provide recommendations to the Board


- Community Planning Organizations (CPO) Members (s)
- Business Representative(s)
- Potential government officials from neighboring counties.
- Prior/former elected officials (Clackamas County and Clackamas Cities)
- Local government attorney
- Special district elected officials – current or former

The BCC has instructed that the committee focus its review and recommendations on the following topics:

- Elected Chair,
- Districts,
- Partisan/Bipartisan commission members.
