**EXECUTIVE SUMMARY**: The Budget Committee for EX4H approved the FY25-26 budget on May 27, 2025. The attached resolution adopts the budget of \$18,706,852 as approved and in accordance with Oregon Budget Law ORS 294.

**RECOMMENDATION:** Staff recommends approval of the resolution to adopt the EX4H budget of \$18,706,852, impose a permanent tax rate of \$0.050 per \$1,000 of assessed value on property within the district, and categorize the taxes as subject to General Government limitations.

- 2. Impose ad valorem property taxes for tax year 2025-2026 upon the assessed value of all taxable property within the District at the rate of \$0.0500 per \$1,000 of assessed value for permanent rate tax; and
- 3. Per Article XI section 11b, categorize as subject to General Government Limitations.
