# 7. Mark Hillyard, Director at Large

- **a.** Park Committee Open Air Markets June, July & August Wed. Evenings 4:30-8 6/11, 18, 25 & 7/9, 16, 23, 30, 8/6, 13, 20 Open Air Markets completed for this season. Vendors said "most enjoyable ones, compared to other cities". Red's BBQ and Bread folks had quite a following.
  - i. Rummage Sales June 28 & 29, July 26 & 27. June was slow, but July picked up pace and shows progression. This will be carried onto next year.
  - ii. National Night Out August 5. Compared to last year, it was not as robust. Sheriffs Rep / Fire Truck rides all arrived later into the event. The County backhoe & vacuum truck was a success and they attended the entire event. For next year we need to do a better job of getting word out about the event, to improve to get it back to last year. We use FB, other Social Media and the National website.
  - **iii.** Summer Fest Concert August 23 Postponed and new date TBD, likely mid September , due to extreme weather 100 degrees +. Band is willing to shift, and main vendors have been contacted, and now local businesses in discussion.
  - iv. Holiday Tree Lighting December 6<sup>th</sup> Moving forward, Santa Claus has been contacted. Christmas Tree still being looked into to ensure that all electrical issues resolved for this year.
  - v. Cheryl mentioned the electric bill went up, Mark stated that its being used food trucks, lights, etc. Cheryl mentioned that the money comes from county funds, so for future conversation as to whether we would get a contribution from another source.
- **b.** Clackamas County Coordinating Committee (C4) Hamlet Representation Mark was not present.

- a. Clackamas Soil and Water Conservation District Board Member Report
  - i. Puncture Vine is the weed of the month.
- **b.** Chris Lapp, CSWCD Barn Hybrid Meeting (8/20 6:30 pm)
  - i. 3 community members present (2 of them were our board members)
  - ii. Option 1: \$400k try to fix the major structural issues, visual only
  - iii. Option 2: \$308k remove lean to, register at county, visual only
  - iv. Option 3: \$40k Do nothing put a fence, move driveway, visual only
  - v. Option 4: \$40k Tear Down, rebuild and restore waterways.
  - vi. Basically, no options for public use at all. Also must use prevailing wages so thus the costs. Also infested with bats, owls, etc...Its holding up progress for classes to be held, restoration on the waterways, etc...TAKE THE SURVEY (when they post it its missing from their website as of now, along w/ the actual meeting)
- c. What is happening with Social Media? Joe asks. Bill mentioned some posts are going out, but we don't have a backup plan in place. We all agree that we need some others to have the credentials so that we can ensure all posts are getting out, especially last minute changes.
- d. Bill asked Gina to go into the Analytics section give a report on what's going on w/ website. 275 visits this month, 70% less than last month.
- e. Hamlet Elections We need to put something on the website and social media, to start recruiting for board members. Also add this to the agenda. Who are the people up for re-election? Anyone up would need to fill out the application. Bill will ask the County if there are any applications already submitted.
