

Appointed Boards and Commissions (ABCs) Recommendation

The Clackamas County Community Health Council, under the Health, Housing and Human Services Department, opened their recruitment for consumer and non-consumer representation. The Community Health Council has a federal grant requirement to maintain a majority of consumer members, and its by-laws require a minimum of nine members. This ABC holds a current roster of 9 members.

Members voted unanimously at the regularly scheduled meeting on January 21, 2025 to recommend reinstating member, Jerome Dalnes to serve their second term on the council.

Jerome is a consumer, who has past work experience and perspective managing and working with FQHC's and performing research and working for the National Health Service in Britain.

Our recommendation is as follows:

Jerome Dalnes – Appointment to 2nd term to end February 29, 2028

The Board of County Commissioners could select other candidates or require further recruitment.
