#### **EXECUTIVE SUMMARY:**

Nehalem, LLC, as the assignee of the previous owner, has requested to repurchase 00634825 / 23E24 00200 & 00634834 / 23E24 00201, parcels foreclosed upon in 2019 for delinquent property taxes. The unimproved parcels total approximately 24 ac. and are located off SE Holst Rd. & Judd Rd., in Eagle Creek, OR. Nehalem, LLC has submitted payment for \$66,440.59, which represents the amount to reimburse the County for all costs associated with the parcels. DTD Property Disposition, under the authority granted by the Board of County Commissioners, accepted their offer and has prepared the required documentation to complete the transaction.

Clackamas County forecloses on tax-delinquent properties through a six-year process: three years of delinquency, a two-year right of redemption after a foreclosure judgment is then filed, and then

foreclosure in the sixth year. The properties are then deeded to the county and managed by the Department of Transportation and Development's Property Disposition Program.
