The meeting was called to order at approximately 9:00 am.

Introductions:

- Introductions were completed.

Additions/Deletions/Acceptance of Agenda:

Call to the Public:

Approval of Minutes:

- October 21st, 2024, Meeting Minutes approved.

Recognitions:

- Chief Matt Dale, new Fire Chief of Canby Fire

Staff Reports:

- County Staffing Update (Bill Conway)
 - Office of Public Health Emergency Services (OPHES) is fully staffed with the new addition of Community Paramedic, Jamie Breunig.
 - Focusing on Public Health
 - Houseless outreach
 - Opioid and polysubstance abuse or use
 - Behavioral Health
 - General Outreach, identifying gaps, and connecting those most vulnerable to appropriate resources
- Public Health Update (Dr. Sarah Present)
 - Respiratory viral season ending.
 - Covid levels have been low for quite some time.
 - Influenza has started to have significant declines.
 - Under 10% for the past two weeks, 5% last week.
 - Record setting influenza year, Flu B watching for potential spike
 - RSV is still prevalent
 - Concerns around notification for emerging diseases
 - Communication changes at the federal level
 - Keeping on a close eye on Measle outbreaks in the southern portion of the

United States.

- Finance (Sherry Olson)
 - Not Present, No Update.
- Behavioral Health Response Update (Matt Dale)
 - Bill Conway – Clackamas County is working on the JULOTA Platform.
 - Currently working on getting the Community Paramedic piece running.
 - Glen Suchanek – Stabilization Center, Recovery Center, and Caring Place
 - Recovery Center – Flora Health will be the contractor
 - Stabilization Center:
 - Front end is the 24-hour stabilization center
 - Back-end shelter will be run by Father's Heart
 - Caring Place will be in the Miles Fiber Glass building in Oregon City.
 - The old building is down. Construction starts at the end of the year.
 - Projected opening is 2027
 - Clackamas Village – Ribbon cutting May 14th, 2025, opening in June
 - CCOM mentioned the addition of Steve O'Sullivan, a Behavioral Health worker embedded within CCOM
 - Works Sunday night through Wednesday, 1 of 2 positions that will cover the week.

Committee / Special Interest Reports:

- EMS Strategic Plan Taskforce (Bill C.)
 - No new report
- QI Committee (Dr. Ritu Sahni/ Dr. John Turner)
 - Last quarter the group met about Strategic Annual Planning, Myocardial infarction, Substance Use
- Protocol Development Committee (Dr Ritu Sahni)
 - Met in March and April
 - New Protocol- Working on new protocols for heat emergencies that will include a more active cooling protocol. Working to implement the new protocol this summer.
 - National standards are moving from passive to more aggressive approach to partially due to increasing temperatures and the amount of time it can take for a hospital to start treatment.
- Operations Subcommittee (Brad Kuhn)
 - Bag Valve Masks
 - Tested at MAT
 - Medication shortage has been added as a regular topic and has been helpful in locating medication sources.
- System Enhancement Subcommittee (Jason Mahle)
 - Timberline Conference – awarded \$20,000 for scholarships. The conference is this weekend.
 - Video Laryngoscopes:
 - Project needs a bit more money to fund the system wide upgrade. This topic is currently being discussed with the county.

- ESO Committee (Scott Vachter)
 - Two new committee members. Robert Toombs from Molalla, Scott Herzog from Canby.
 - Focus has been on data. Working with Deidre to standardize data for both KPI and uniformity with all agencies.
 - Currently evaluating creating custom forms.
 - Jason Mahle – Clackamas County and Washington County AMR changed to using the County run number for all charts in ESO. For Qi, the run number is the same as fire.
- EMS Training Group/MAT (Dr. Sahni)
 - MAT is being held at Clackamas County AMR.
 - 6 days of training were this April.
 - Topics covered were Qi topics:
 - Capacity assessment, severe respiratory distress caused by heart failure, proper management and documentation of severely agitated patients.
- Emergency Physician Advisory Board
 - Dr. Sahni mentioned the return of EPAB, Emergency Physicians Advisory Board
 - Adding the EDs to the invitation.
- PSAP (Cheryl Bledsoe)
 - Tony will be out for some time, please check in with Cheryl for any open requests
 - Steven O'Sullivan is with CCOM as a Behavioral Health addition
 - Final two vacancies are starting training on May 4th.
 - All budgeted positions are now filled
 - Last week was Telecommunicator Week so both LOCOM and CCOM were heavily involved in recognizing their dispatchers
- Labor Committee (Bill S/Mark O.)
 - No report
