Appointed Boards and Commissions (ABCs) Recommendation

The Clackamas Workforce Partnership, currently has 4 openings (2 from open recruitment and 2 appointments) on their board due to member resignation and adjustments by the Higher Education Coordinating Commission (HECC). 25 members are allowed with 3 year terms.

Recruitment opened to the public on February 19, 2026, and closed on April 3, 2026, for two business seats. Recruitment took place by social media, newsletters, direct email outreach, and the County website. Through this recruitment process, 4 applications were received for the business seats and 2 are recommended to be appointed as business representatives.

Recruitment for the appointments was not open to the public, as the positions were open only to representatives of organizations that have demonstrated experience and expertise in:

- governmental and economic and community development entities serving the local area, who is a representative of economic and community development entities; Workforce Innovation and Opportunity Act (WIOA Section 107(b)(2)(D)(i))
 - This seat is open due to a mid-term resignation. The replacement representative will serve the remainder of the term, through October 8, 2027, before being eligible to start their first term, as required by the Higher Education Coordinating Commission.
- labor organization recommended by the Oregon AFL-CIO's workforce labor liaison, under the Workforce Innovation and Opportunity Act (WIOA Section 107(b)(2)(B)(i)).

Interviews were conducted with each qualified applicant.


