### EXECUTIVE SUMMARY:

Clackamas County previously leased all three suites of the Willamette Building at 104, 108, and 112 11<sup>th</sup> Street, Oregon City, from Willamette Building Partnership, to house the H3S Children, Family, and Community Connections (CFCC) Division Programs. The County vacated Suite 104 as of December 31, 2025, and Lease Amendment #4 covers only the one (1) month extension for Suites 108 and 112 from January 1-31, 2026.

CFCC is comprised of the Workforce Program, Resolution Services Program, and Prevention Program. These program partners provide local self-sufficiency, employment training and career development, and one-on-one support services for clients.

CFCC management and Facilities Management staff have worked closely this past year to determine building repairs, required improvements and space remodel standards to transition the Ralph M. Holman Law Center into a new facility home for CFCC services.

The County requires this additional one (1) month to complete the final Holman Building remodel, move the remaining CFCC staff, and turn the Willamette Building back over to its owner by January 31, 2026.

**RECOMMENDATION:** Staff respectfully recommend that the Board approve and sign Lease Amendment #4 with Willamette Building Partnership.

#### LEASE AMENDMENT #4

This Lease Amendment #4 ("Amendment #4") is entered into between Willamette Building Partnership ("Lessor") and Clackamas County ("Lessee") and shall become part of the lease entered into between both parties June 27, 2019 ("Lease") for the property located at 104, 108 and 112 11<sup>th</sup> Street, Oregon City, Oregon.

The purpose of this Amendment #4 is to make the following changes to the Lease:

##### 1. Lease term

The lease term is for only 108 and 112 and is hereby extended for a period of one month, beginning January 1, 2026, and ending at midnight on January 31, 2026.

##### 2. Base Rent

For the extended lease term, beginning January 1, 2026, Lessee agrees to pay one rent payment for the month of January 2026 by January 15, 2026, in the amount set forth below.


