EXECUTIVE SUMMARY: Trillium Community Health Plan, Inc. is a Coordinated Care Organization in Oregon that manages healthcare for Oregon Health Plan (Medicaid) members within Clackamas County. Through this agreement, the Public Health Division of the Health, Housing & Human Services Department provides the following:

- Tuberculosis screening, treatment, and case management
- Community health improvement projects
- Communicable disease prevention activities
- Coordination of County-operated regional maternal and child health services

This amendment extends the County's revenue-generating Administrative Services Agreement with Trillium Community Health Plan, Inc., for three months, which allows the Public Health Division to continue receiving reimbursement for services provided to Trillium members.

RECOMMENDATION: Staff respectfully request that the Board of County Commissioners approve this amendment to the agreement (11905) and authorize Chair Roberts or his designee to sign on behalf of Clackamas County.

AMENDMENT NO. 1 ADMINISTRATIVE SERVICES AGREEMENT CC# 11905

This Amendment No. 1 ("Amendment") to the Administrative Services Agreement is entered into on December 31, 2025 ("Effective Date"), by and between **Clackamas County, Oregon**, a municipal corporation ("County" or "Vendor") and **Trillium Community Health Plan, Inc.** ("Trillium" or "Health Plan"), collectively referred to as the "Parties", with reference to the following facts:

WHEREAS the Parties entered into an Administrative Services Agreement, CC# 11905, effective January 1, 2024 (the "Agreement"); and

WHEREAS the Parties desire to extend the term of the Agreement.

Now therefore, in consideration of the mutual promises, covenants, agreements, and other undertakings set forth herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree for the Agreement to be amended as follows:

- 1. Term Extension.** The Term of the Agreement is hereby extended through March 31, 2026. All terms, conditions, and provisions of the Agreement shall remain in full force and effect through the extended term.

Except as amended and modified by this Amendment, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect. This Amendment may not be modified except in writing signed by both parties hereto. This Amendment, the Agreement, together with its attachments, as previously amended in each case, constitute the entire agreement of the parties with respect to the subject matter contained therein and supersede any and all prior contemporaneous agreements between the parties, whether oral or written, concerning the subject matter contained herein.

Each Party represents and warrants that it has full authority to enter into this Amendment and that the individual signing on behalf of each Party has been duly authorized to execute this Amendment.
