EXECUTIVE SUMMARY: Clackamas County has had a contract with Total Golf Management Services, LLC (TGMS) for management services for the operation of Stone Creek Golf Club since 2005. TGMS has done an exceptional job of managing the

has done an exceptional job of managing the operations of the golf course and associated facilities, while maximizing revenue to the County.

Prior to this one-year extension, the agreement has had three five-year extensions. This 12-month extension allows time for the Department of Transportation and Development to plan for, and possibly construct, the replacement of the

irrigation system at the golf course in the next 12 months. Simultaneously a Request for Proposals for golf course management and operations will be published so that the management contract receives open competition. This timeline allows for a management company to be selected in the coming year and prepared to assume management of the golf course on October 1, 2026.
