**Approval of a Resolution Supporting the Sunrise Corridor Community Vision Plan and the Sunrise Gateway Refinement Plan. If funded, total Plan Value is \$15,500,000.  
Funding source may be Metro Regional Flexible Funds.**

<b>Previous Board Action/Review</b>	On April 29, 2025, the Board of County Commissioners received a staff presentation during a Policy Session on the Sunrise Corridor Community Visioning Project. The presentation summarized the two-year community visioning process, funded through a \$4 million allocation from the Oregon Legislature via HB 5006 (2021). Staff presented the co-created Sunrise Corridor Community Vision Plan and Sunrise Gateway Refinement Plan, and requested Board direction to prepare a formal Resolution of Support. The Board accepted the recommendation and directed staff to proceed with resolution preparation for Board consideration at a future Business Meeting.

**EXECUTIVE SUMMARY:** Clackamas County Department of Transportation and Development (DTD) is requesting approval of a Resolution in support of the Sunrise Corridor Community Vision Plan, including the Sunrise Gateway Refinement Plan. These two documents represent the culmination of a two-year community-driven process to co-create a vision for equitable growth, multimodal transportation, economic opportunity, and public health in the Sunrise Corridor of unincorporated Clackamas County and the City of Happy Valley.

Over 1,500 individuals participated in the process through surveys, focus groups, workshops, and public events, supported by a Steering Committee of agency and community stakeholders and a Leadership Cohort of local residents. The Vision Plan identifies a shared community framework, priority actions, and implementation strategies for the corridor. The Sunrise

Gateway Refinement Plan identifies community-informed recommendations to the 2011 Selected Alternative in the Federal Highway Administration's Record of Decision to inform a required National Environment Policy Act (NEPA) reevaluation and support regional and state funding efforts.

This resolution affirms the Board's support for the Vision Plan and Refinement Plan and acknowledges the County's commitment to continued interagency collaboration and community-led implementation. It also strengthens the County's position in ongoing coordination with the Oregon Department of Transportation (ODOT), the Federal Highway Administration (FHWA), and Metro regarding project readiness, environmental review, and funding eligibility.

**RECOMMENDATION:** Staff respectfully recommends approval of the Resolution supporting the Sunrise Corridor Community Vision Plan and Sunrise Gateway Refinement Plan, and affirms the County's support for continued implementation, community collaboration, and regional coordination.

**Whereas**, the Board adopted the Sunrise Corridor Community Visioning Project as a legislative priority in 2021, and the Oregon Legislature subsequently allocated \$4 million in state funds (HB 5006) to develop the vision; and

**Whereas**, as part of the Visioning Project, Clackamas County, in collaboration with the City of Happy Valley, the Oregon Department of Transportation (ODOT), Metro, TriMet, and other regional partners, has undertaken a two-year community-driven process to create a shared vision for a five-square-mile area encompassing unincorporated Clackamas County and Happy Valley; and

**Whereas**, the Visioning Project has engaged thousands of residents, business owners, and stakeholders through more than 100 outreach events, including surveys, focus groups, open houses, advisory meetings, and multilingual engagement strategies; and

**Whereas**, a Steering Committee, composed of 21 community and agency representatives, reached unanimous consensus on April 2, 2025, to recommend the Sunrise Corridor Community Vision Plan to the Board for formal acceptance; and

**Whereas**, a Leadership Cohort, composed of local residents and community leaders, played a central role in shaping the Vision Plan and will continue its involvement as part of a community-led coalition responsible for advancing early stages of implementation, including project prioritization, community organizing, and stakeholder collaboration; and

**Whereas**, the Vision Plan outlines a community-supported framework that promotes neighborhood-oriented growth, public health, economic prosperity, and a safe, multimodal transportation system; and

**Whereas**, the Sunrise Gateway Corridor Refinement Plan, a component of the Vision Plan, documents community-supported refinements to the Selected Alternative in the Federal Highway Administration's (FHWA's) 2011 Record of Decision (ROD) to inform a National Environmental Policy Act (NEPA) reevaluation and to position the project for future funding and implementation; and

**Whereas**, adoption of this resolution is not a regulatory action but a formal expression of support that enables continued coordination with ODOT, FHWA, and Metro to support project readiness, environmental review, and eventual integration into regional and state transportation plans;
