**EXECUTIVE SUMMARY:** The Justice Reinvestment Program dedicates funding for victim services programs. The funds will be used to continue to provide trauma-informed care for children when there are concerns of physical abuse, emotional abuse, sexual abuse, neglect, drug endangerment, or if a child has witnessed domestic violence, and to provide Spanish-speaking children culturally appropriate support and services provided by bilingual/bicultural staff.

**Justification for Amendment:**

This Amendment #01 is entered into by and between Clackamas County ("COUNTY") and Children's Center ("SUBRECIPIENT") and will become a part of that subrecipient agreement (Agreement") originally entered by and between the parties on February 12, 2026.

This Amendment #01 extends the Agreement term through July 31, 2027, and adds to the maximum compensation available through this Agreement.

Maximum compensation is increased by \$26,494.01 to a revised value of \$52,988.02. This Amendment #01 is effective upon signature and continues through July 31st, 2027.
