

Appointed Boards and Commissions (ABCs) Recommendation

The Clackamas County Community Health Council, under the Health, Housing and Human Services Department, opened their recruitment for consumer and non-consumer representation. The Community Health Council has a federal grant requirement to maintain a majority of consumer members, and its by-laws require a minimum of nine members. This ABC holds a current roster of 6 members.

Members voted unanimously at the regularly scheduled meeting on October 15, 2025 to reappoint current member, Tara Schoffstall, to serve her second term on the council.

Tara is a consumer of Clackamas County Health Centers, who is interested in supporting and engaging with the community. She is a leading member of the Johnson City Tenant Council.
