**EXECUTIVE SUMMARY:** The Health Centers Division of Health, Housing, and Human Services Department requests approval of Amendment #1 to a revenue agreement with CareOregon, Inc. The purpose of this amendment is to extend the agreement term and update exhibits for the extended term.

This agreement allows the Health Centers Division to participate in CareOregon's Primary Care Payment Model Program. The Health Centers Division is eligible to receive a per-member-per-month (PMPM) value-based payment comprised of up to four (4) focus area components based on level of achievement in these areas: Clinical Quality Incentive Payment, Equity Focus Area Payment, Behavioral Health Integration Incentive Payment, and Oral Health Integration Incentive Payment. The clinics participating in this program are Beaver Creek, Gladstone, Sunnyside, and Sandy.

**RECOMMENDATION:** The staff respectfully requests that the Board of County Commissioners approve amendment #1 to this agreement (11714) with CareOregon, Inc., and authorize Chair Roberts or his designee to sign on behalf of Clackamas County.

**AMENDMENT #1**  
**To the**  
**Healthcare Services Contract**  
**Between**  
**CareOregon, Inc.,**  
**and**  
**Clackamas County**

This is the first amendment ("Amendment") to the Healthcare Services Contract ("HSC"), Primary Care Payment Model, that was effective July 1, 2024, between CareOregon, Inc. ("CareOregon") ("CCO") and Clackamas County ("Provider").

CareOregon, Inc. and Provider agree that the HSC between the Parties be hereby amended as follows:

1. **Section II. A. Term** is hereby replaced in its entirety with the following: "This HSC is effective as of **July 1, 2024** ("Effective Date") and shall remain in effect through **December 31, 2025** ("Termination Date") unless sooner terminated as stipulated for herein.
2. The following sections of **Exhibit A** are hereby amended as follows:
  - a. The paragraph beginning with, "Performance reporting for each focus area..." is amended to read as follows: "Performance reporting for each focus area component will be concurrently submitted from all participating clinics during three (3) measurement reporting submission events due **August 30, 2024, February 28, 2025, and August 29, 2025**, utilizing the same data collection platform, ShareFile. ShareFile is a secure HIPAA-compliant file sharing system and is the designated application CCO utilizes for data sharing in this program. CCO will create reporting access for the Provider's selected representatives to ShareFile as submitted on the program application form, or as requested by Provider. If Provider is unable to utilize the ShareFile application for data submission, Provider will need to contact CCO to establish an alternative, approved data submission method."
  - b. The paragraph beginning with, "Any resulting payment level..." is hereby amended to read as follows: "Any resulting payment level adjustments will occur on the **December 2024** and **June 2025** payment adjustment dates respectively. There will be no payment level adjustments for the submission event due **August 29, 2025**." The payment rates applied in June 2025 will be utilized through December 2025. Any future payment level adjustments will be memorialized through a signed agreement between CareOregon and Provider.
3. The following sections of **Exhibit B** are hereby amended as follows:
  - a. Section A.1. is hereby amended to read as follows:
    1. CCO agrees to pay participating clinics a monthly PMPM incentive payment, provided this HSC is fully executed, according to the following timelines:

- a. If this HSC is executed prior to June 5<sup>th</sup>, 2024, PMPM will commence on the HSC effective date.
    - i. **If this Amendment is executed prior to July 5<sup>th</sup>, 2025, PMPM will commence on the Amendment effective date.**
  - b. If this HSC is executed between the 6<sup>th</sup> and the 15<sup>th</sup> of June 2024, PMPM will commence in August 2024.
    - i. **If this Amendment is executed between the 6<sup>th</sup> and the 15<sup>th</sup> of July 2025, PMPM will commence in August 2025.**
  - c. If this HSC is executed after June 15, 2024, CCO will advise Provider when the first payment processing month can occur due to system requirements.
    - i. **If this Amendment is executed after July 15<sup>th</sup>, 2025, CCO will advise Provider when the first payment processing month can occur due to system requirements.**
  - d. Due to system processing requirements at CCO, no retroactive payments will be remitted to Provider due to late HSC **or Amendment** execution.
  - e. Measure improvement targets will not be adjusted based on timing of HSC **or Amendment** execution.
