Whereas, the Clackamas County Board of County Commissioners (the “Board”) has authority to sign all contracts and any amendments or renewals of the same;

Whereas, Oregon Revised Statutes (“ORS”) Chapter 279A.200-220 and Local Contact Review Board Rule C-046-0400 permit Clackamas County to purchase goods and services using cooperative contracts;

Whereas, OMNIA Partners, dba OMNIA Partners, Public Sector, established cooperative contract 23-6692-03 with Insights Public Sector (“Contractor”) for the purchase of IT Products and Services (“Cooperative Contract”);

Whereas, Contractor offers Mark 43 Records Management Software subscription services;

Whereas, Clackamas County Sheriff’s Office, desires to utilize the Cooperative Contract to purchase a Five-year Subscription of Mark 43 software services, as detailed in Contractor’s public sector quote 0228340931, attached hereto as Exhibit A (“Contractor Quote”), for a total of \$1,260,987.00 (“Software Subscription”);

Whereas, the Clackamas County Department of Finance requests authority to use the Cooperative Contract to purchase the Software Subscription by issuance of purchase orders (“POs”); and

Whereas, POs are issued directly through the Clackamas County Department of Finance’s management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:

1. The requested purchase of the Software Subscription and services from Contractor in the amount of \$1,260,987.00 using the Cooperative Contract is hereby approved;
2. The Clackamas County Department of Finance is hereby delegated limited authority to issue POs to purchase the Software Subscription.
