STATEMENT OF RIGHTS

- 1. Prior to the Hearing. You have the right to make the following requests:
 - (A) You can request the opportunity to review public records and talk to County Staff about the violations or request a subpoena for that purpose if the County does not allow you to do so.
 - (B) You can request that the Hearings Officer postpone the hearing for good cause by writing the Hearings Officer at least 7 calendar days prior to the scheduled hearing date.
 - (C) You can request that the Hearings Officer decide the matter based exclusively on written materials from the parties or conduct the hearing by phone.
- 2. Procedure. The hearing will be governed by general rules of procedure designed to allow you to hear and confront the evidence against you, and for you to present evidence favorable to you. You are not required to present any evidence; the burden is on the County to establish by a preponderance of evidence that a violation exists or existed. Either party may, at their own expense, obtain an attorney, to represent that at the hearing. If you wish to be represented by an attorney, they need only notify the County and the Hearings Officer in writing of their intent to appear on your behalf. The County will present evidence first, and then you may question that evidence. You may then present your own evidence, if you wish, and the County may question your evidence. Testimony by witnesses is evidence. The Hearings Officer may inquire into any facts that are relevant to the hearing and may question parties or witnesses about the case. Evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their serious affairs shall be admissible.
- 3. Record of Proceedings. An audio record will be made of the proceedings when a hearing is conducted. The audio record is available through the Clackamas County Code Enforcement Section and is available to you upon request.
- 4. Hearings Officer. The Hearings Officer is an independent contractor paid by the County to conduct hearings and render decisions. He/she is not a County employee. His/her function is to preside over the hearing, make a record of proceedings, consider admissible evidence and interpret and apply the law. After the hearing is closed, the Hearings Officer will enter written findings of fact, conclusions of law and any Order deemed proper. If a violation is proven, then the Order may include civil penalties, fines, administrative fees, or may require the respondent to take certain actions, or refrain from certain actions. An Order issued by the Hearings Officer may be a final order or a continuing order. The Hearings Officer Order is the final decision of the County, and may be appealed pursuant to Oregon Law. - <u>5. Right to Recess.</u> If, during the course of the hearing, the Respondent or the County requests a recess or postponement, or additional time to present crucial evidence, the Hearings Officer may allow a continuance of the hearing for good cause. The Respondent may also request that the proceedings be continued after the end of the hearing if the Respondent determines that additional evidence should be brought to the attention of the Hearings Officer.
- **<u>6. Right to Appeal.</u>** The Final Order of the Hearings Officer shall set forth the right of the respondent to appeal any adverse Order. Appeal may be taken pursuant to Section 2.07.130 of the Clackamas County Hearing Officer Code, and Oregon Revised Statute 34.010-34.100. If appeal is taken, the appellant is responsible for all costs of appeal including preparation of transcript.

I, Diane Bautista, Code Enforcement Specialist for Clackamas County, allege the following:

1.

Respondent's mailing address is: 21498 SW Jay St., Beaverton, OR 97003.

The address or location of the violation(s) of law alleged in this Complaint is: 19380 S. Nelson Ln., Oregon City, OR 97045, also known as T3S, R2E, Section 11, Tax Lot 00611, and is located in Clackamas County, Oregon. The property is zoned AG/Forest (AG/F) outside the UGB and is the location of violation(s) asserted by the County.

3.

On or about the 21st day of April, 2025 and June 10, 2025, the Respondents violated the following laws, in the following ways:

Page 1 of 3 – COMPLAINT AND REQUEST FOR HEARING File No. $\,$ V0005825

a. Respondents violated the Clackamas County Building Code, Title 9.02 by failing to obtain a Change of Use permit for agricultural exempt building AGM01917. This violation is a Priority 1 violation pursuant to the Clackamas County Violation Priorities.

b. Respondents violated the Clackamas County Excavation and Grading Code 9.03, Section 9.03.030 by failing to obtain a grading permit and approved final inspections for the fill that was brought on site. This violation is a Priority 1 violation pursuant to the Clackamas County Violation Priorities.

4.

The Department initiating this procedure is the Code Enforcement Section of the Department of Transportation and Development.

5.

Notice of the violation was given to Respondents in the following manner: Violation notice dated April 21, 2025 and Citation and Complaint #2500058-2. A copy of the notice documents are attached to this Complaint as Exhibits F and H, and incorporated by this reference.

6.

Based on these allegations, petitioner requests that a hearing be set in this matter.

Petitioner seeks an Order from the Hearings Officer granting the following relief:

1. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondents to immediately abate the violation and bring the property at issue into compliance with all laws, and permanently enjoining Respondents from violating these laws in the future;

against Respondent for each violation, within the range established by the Board of County

\$1,000.00 per occurrence as provided by Appendix B to the Clackamas County Code; and said

range for a Excavation and Grading Code Title 9.03 Priority 1 violation being \$1,000.00 to

\$3,500.00 per occurrence as provided by Appendix B to the Clackamas County Code;

3. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondents to pay

an administrative compliance fee as provided by Appendix A of the Clackamas County Code;

February 13, 2025 Clackamas County received a complaint regarding an agricultural

exempt accessory structure being used for an auto repair business

and a large amount of fill brought on site.

February 19, 2025

Fxhibit A

Correspondence was sent to the Respondents regarding the auto

repair business.

March 4, 2025

Exhibit B

I conducted a site inspection and confirmed an auto body shop was

operating in the agricultural exempt building.

March 6, 2025

Exhibit C

Correspondence was sent to the Respondents for the inoperable and/or non-currently licensed vehicles and operating an auto repair

business without land use approval with a deadline of April 6, 2025.

April 15, 2025

Exhibit D

I conducted a site inspection and confirmed several vehicles registered to owners in other cities, miscellaneous debris in front of

the shop, vehicles being worked on in the agricultural structure and 2 employees on site. I also located a large amount of fill dirt that had been placed on the back side of the property. The pictures of the fill were reviewed by Plans Examiner Supervisor Richard

Carlson who confirmed a grading permit would be required.

April 16, 2025

Exhibit E

Citation 2500058 in the amount of \$400.00 was issued for operating a car repair business without land use approval. This citation was not returned to the County. This citation remains

unpaid.

April 21, 2025

Exhibit F

Correspondence was sent to the Respondents for not submitting a Change of Use permit for the agriculturally exempt structure and fill

brought on site without a grading permit with a deadline of May 21,

2025.

June 10, 2025 Exhibit G

I conducted a site inspection and confirmed an auto body shop was operating in the agricultural exempt building.

June 11, 2025 Exhibit H Citation 2500058-2 in the amount of \$500.00 was issued for failure to obtain a Change of Use permit for the agriculturally exempt structure being used for a commercial business and for failure to obtain a grading permit for the fill placed on site. This citation was not returned to the County. This citation remains unpaid.

June 24, 2025 Exhibit I On June 24, 2025 I met with Javier and Paul on site. The agricultural building was empty and no longer being used as an auto repair business. Javier stated that the 12 inoperable and/or non currently licensed vehicles would be removed within 2 weeks. We also walked down the driveway and I photographed the fill from the upper level of the slope. These photos were reviewed by Richard Carlson and he advised that more than 50 yards of fill requires a grading permit and Respondents will need to provide a site plan and an evaluation from a Geotech.

July 22, 2025 Exhibit J I conducted a site inspection and 6 inoperable/non-currently licensed remain on site. I also reviewed our permitting system and no Change of Use or grading permit had been submitted.

July 28, 2025 Exhibit K

Citation 2500058-3 in the amount of \$308.00 was issued for an accumulation of inoperable and non-currently licensed vehicles. This citation was not returned to the County. This citation remains unpaid.

September 2, 2025 Exhibit L

I conducted a site inspection and only 2 vehicles remain on site. Solid Waste violation reduced to a low priority violation. Auto repair business no longer operating from this site. Zoning violation abated. No permit applications have been received for grading or a change of use for the agricultural structure.

September 4, 2025

The County referred this matter to the Code Enforcement Hearings Officer.

If the Compliance Hearings Officer affirms the County's position by a preponderance of the evidence, the County may request a Final Order in this matter recommending the following:

- The imposition of civil penalties for the Building Code Violation of up to \$1,000.00 for date cited June 11, 2025.
- The imposition of civil penalties for the Grading Code Violation of up to \$3,500.00 for date cited June 11, 2025.
- Payment for Citation 2500058 for \$400.00 issued on April 16, 2025.
- Payment for Citation 2500058-2 for \$500.00 issued on June 11, 2025.
- Payment for Citation 2500058-3 for \$308.00 issued on July 28, 2025.
- The administrative compliance fee of \$75.00 to be imposed from March to June 2025 for a total the amount of \$225.00.
- The administrative compliance fee of \$100.00 to be imposed from July 2025 until the violations are abated. As of this report the total amount due is \$300.00. For a total amount of \$525.00.
- Hearings Officer to authorize the County further enforcement action including to proceed to Circuit Court.





This letter serves as notice of violation of the Clackamas County Code. The violation includes:

- Operating an automotive restoration business without land use approval
- Accumulation of inoperable and/or non-currently licensed vehicles

VIOLATIONS & HOW TO RESOLVE

Operating Automotive Restoration business without Land Use Approval

Currently an automotive restoration business is operating from this site without land use approval. This constitutes a violation of Clackamas County Zoning and Development Ordinance, Title 12, Section 704.04. The subject property is zoned AG/Forest District (AG/F). In this zone businesses must receive land use approval in order to operate. You must abate the violation by completing one of the following no later than April 6, 2025:

- Cease the unauthorized use and schedule an inspection to confirm, or;
- 2. Contact the Clackamas County Planning Department regarding a potential Home Occupation Permit, submit the appropriate paperwork which is available on our website at www.clackamas.us/planning/supplemental.

- If you pause the use and begin the land use process, we will pause the
 enforcement of this file. If the use continues on the property before you
 obtain land use approval, we will continue with the enforcement of this file.
- If you obtain land use approval, you must implement all conditions of approval before staff will close this file. A final inspection may be required to confirm that all conditions of approval have been implemented.

Inoperable and/or Non-Currently Licensed Vehicles

Inoperable and/or non-currently licensed vehicles constitute a violation of Solid Waste and Waste Management Code, Title 10, Chapters 10.03.060 (A) and (B), as it provides a condition of unsightliness and is considered a public nuisance. In order to abate the violations, you must complete the following **no later than April 6, 2025:**

- Remove the inoperable and/or not currently licensed vehicles from the subject property, and/or;
- Render the inoperable and/or currently unlicensed vehicles, operable and licensed, and/or;
- Place the inoperable and/or not currently licensed vehicles inside a permitted structure, and/or;
- Screen no more than two (2) vehicles from view of the road and surrounding properties, in accordance with the minimum screening requirements of the code (see Title 10.03.060 (C)). Please note: placing vehicles under tarps or tarp structures does not remedy the violation.

REQUIRED NOTICE OF FINES AND PENALTIES

It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, (2) assessment of a \$75 per month administrative compliance fee, and (3) referral of this matter to the County Code Enforcement Hearings Officer.

Clackamas County Code provides for fine amounts of up to \$500 and additional civil penalties of up to \$3,500 for each day the County verifies the noncompliance. Fine amounts and civil penalties may be assessed for each cited violation and may be assessed separately against each named party. In addition, the Code Enforcement Hearings Officer may order the violation to be abated by the County at the expense of the property owner(s) and responsible parties.

Clackamas County encourages voluntary compliance with code violations to support a safe and healthy community for all. Please note that when a property owner works cooperatively with the County to resolve a confirmed code enforcement violation, the County may in its discretion waive all or part of the \$75 per month administrative fee.

Fines and costs are payable upon the effective date of the final order declaring the fine and costs. Fines and costs under this Chapter are a debt owing to the County, pursuant to ORS 30.460, and may be collected in the same manner as any other debt allowed by law. If fines or costs are not paid within 60 days after payment is ordered the County may file and record the order for payment in the County Clerk Lien Road.
