EXECUTIVE SUMMARY: The Health Centers Division of Health, Housing, and Human Services Department requests approval of Amendment #1 to an intergovernmental agreement with Gladstone School District. The purpose of this amendment is to add time and funds to the agreement.

Under this agreement, the Health Centers Division provides Mental Health Services designed to improve classroom participation, enhance family engagement, and support teachers through targeted interventions. This work aims to explore how part-time behavioral health staff from the Health Centers Division can be co-located in the Gladstone School District's Early Care and Education setting. This amendment is to continue a pilot project originally funded by Health Share of Oregon and to utilize Mental Health Service interventions to improve classroom participation, family engagement, and teacher understanding. Gladstone School District is funding the continuation of this agreement beyond the first 15 months, previously funded by the Health Share of Oregon.

RECOMMENDATION: The staff respectfully request that the Board of County Commissioners approve Amendment #1 to Agreement #12068 with Gladstone School District and authorize Chair Roberts or his designee to sign on behalf of Clackamas County.

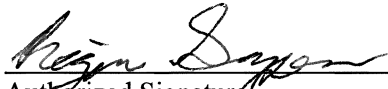
The Purpose of this Amendment #1 is to make the following changes to the Contract:
