**EXECUTIVE SUMMARY:**

Clackamas County Department of Transportation and Development - Transportation Maintenance Division maintains 1,400 miles of roadways having to meet MUTCD standards for retro-reflectivity of roadway striping. This contract amendment is needed to purchase additional traffic paint needed for centerline and edge line striping. Yearly maintenance is required to maintain safety on County roadways.

**PROCUREMENT PROCESS:**

Approval of the amendment purchase is being requested under the Local Contract Review Board Rule C-046-0400, Authority of Cooperative Procurements. The purchase of traffic paint from Ennis-Flint, Inc. will be made with State of Oregon PO-10700-00008436 through Department of Administrative Services.

**RECOMMENDATION:** Staff respectfully recommends the Board approve the purchase of additional road paint and authorizes Procurement staff to issue the PO on behalf of the County.

**Whereas**, the Clackamas County Board of County Commissioners (the “Board”) has authority to sign all contracts and any amendments or renewals of the same;

**Whereas**, Oregon Revised Statutes (“ORS”) 279A.200-220 and Local Contact Review Board Rule C-046-0400 permit Clackamas County to purchase goods and services using cooperative contracts;

**Whereas**, the State of Oregon, through its Department of Administrative Services, established a cooperative contract, contract number PO-10700-8436, with Ennis-Flint, Inc. for the purchase of Road Paints through 2026;

**Whereas**, the State of Oregon, through its Department of Administrative Services, extended cooperative contract number PO-10700-8436 through 2027;

**Whereas**, Clackamas County, Board of Commissioners previously authorized the Department of Transportation and Development (“DTD”), to utilize the aforementioned cooperative contract with Ennis-Flint, Inc. to purchase Road Paint, for a total not to exceed \$800,000, through 2026;

**Whereas**, DTD desires to utilize the aforementioned cooperative contract with Ennis-Flint, Inc. to purchase Road Paint, in an additional amount not to exceed \$200,000, through 2027;

**Whereas**, the Clackamas County Department of Finance requests authority to amend the previously issued purchase order (“PO”) authority by an additional \$200,000 to purchase Road Paint through 2027; and

**Whereas**, POs are issued directly through the Clackamas County Department of Finance’s management software with no signature required or available.

**NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:**

1. The request to utilize the aforementioned cooperative contract with Ennis-Flint, Inc. to purchase additional Road Paint through 2027 is hereby approved;
2. The Clackamas County Department of Finance is hereby-delegated limited authority to amend the previously-issued PO to increase the total not to exceed amount by an additional \$200,000.
