**Approval of a Board Order transferring a portion of N Pine Street to the City of Canby. Order Value is \$513,000 in a one-time payment. Funding is through the Community Road Fund. No County General Funds are involved.**

**EXECUTIVE SUMMARY:** There are certain county roads, such as N Pine Street in Canby, that are wholly, mostly, or partially within various cities throughout Clackamas County. Fragmented jurisdiction over these roads often results in differing road maintenance activities and confusion by the public as to which agency is responsible for the operation and maintenance of the roads.

On September 4, 2025, Clackamas County and the City of Canby entered into an intergovernmental agreement for the jurisdictional transfer of a portion of N Pine Street with the intent of streamlining planned roadway improvements, eliminating confusions to the public, and improving the efficiencies of maintenance and public service. This portion of N Pine Street is located entirely within Canby city limits.

Under the agreement, the County will to provide funds to the City in the amount of \$513,000, which is equal to the cost of a 2" asphalt overlay, replacement of 25 sidewalk ramps to comply with current Americans with Disabilities Act standards, in exchange for the City assuming exclusive jurisdiction over the portion of N Pine Street, being 0.79 miles in length and containing approximately 212,965 square feet of right-of-way. By accepting jurisdiction, the City becomes the "Road Authority" responsible for all maintenance, improvements, permitting, and road standard activities.

**RECOMMENDATION:** Staff respectfully recommends that the Board hold this public hearing and approve the attached Board Order transferring jurisdiction over a portion of N Pine Street.

**Whereas**, ORS 373.270 provides a mechanism for a county to surrender jurisdiction over a county road within a city to the city, provided the city requests or accepts such jurisdiction; and

**Whereas**, N Pine Street, currently labeled as County Road No. 2580 and DTD No. 31030, is a county road, as defined in ORS 358.001; and

**Whereas**, the portion of N Pine Street described in Exhibit “A” and depicted in Exhibit “B” attached hereto and incorporated herein (“N Pine Street”) is within the jurisdictional boundary of the City of Canby; and

**Whereas**, on September 4, 2025, the County and the City entered into an Intergovernmental Agreement related to the transfer of N Pine Street; and

**Whereas**, the Intergovernmental Agreement provides that, once the City completes the process to request jurisdiction over N Pine Street, the County shall give notice and carry out the procedures set forth in ORS 373.270 to determine whether it is necessary, expedient, or for the best interests of the County to surrender such jurisdiction and, if so, to adopt an order surrendering such jurisdiction; and

**Whereas**, on October 15, 2025, the City adopted Resolution No. 1444, requesting the surrender of such jurisdiction; and

**Whereas**, on 11/19/25, 11/26/25, 12/03/25 and 12/10/25, the County published notice of a hearing on this matter in the Lake Oswego Review; and

**Whereas**, on December 18, 2025, a hearing was held before the Clackamas County Board of Commissioners; and

**Whereas**, the Clackamas County Board of Commissioners deems it necessary, expedient, and for the best interest of the County to surrender jurisdiction over N Pine Street;

- Section 1:** Jurisdiction by the County over N Pine Street is surrendered to the City pursuant to ORS 373.270.
- Section 2:** N Pine Street shall be removed from the County's Road Inventory.
- Section 3:** Copies of this order shall be submitted to the Clackamas County Clerk's office for recording, and copies shall be subsequently sent without charge to the Clackamas County Surveyor, Tax Assessor, Finance/Fixed Asset Offices, and DTD Engineering.

All that portion of N. Pine Street, County Road No. 2580, Department of Transportation and Development maintenance No. 31030;

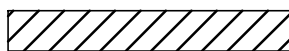
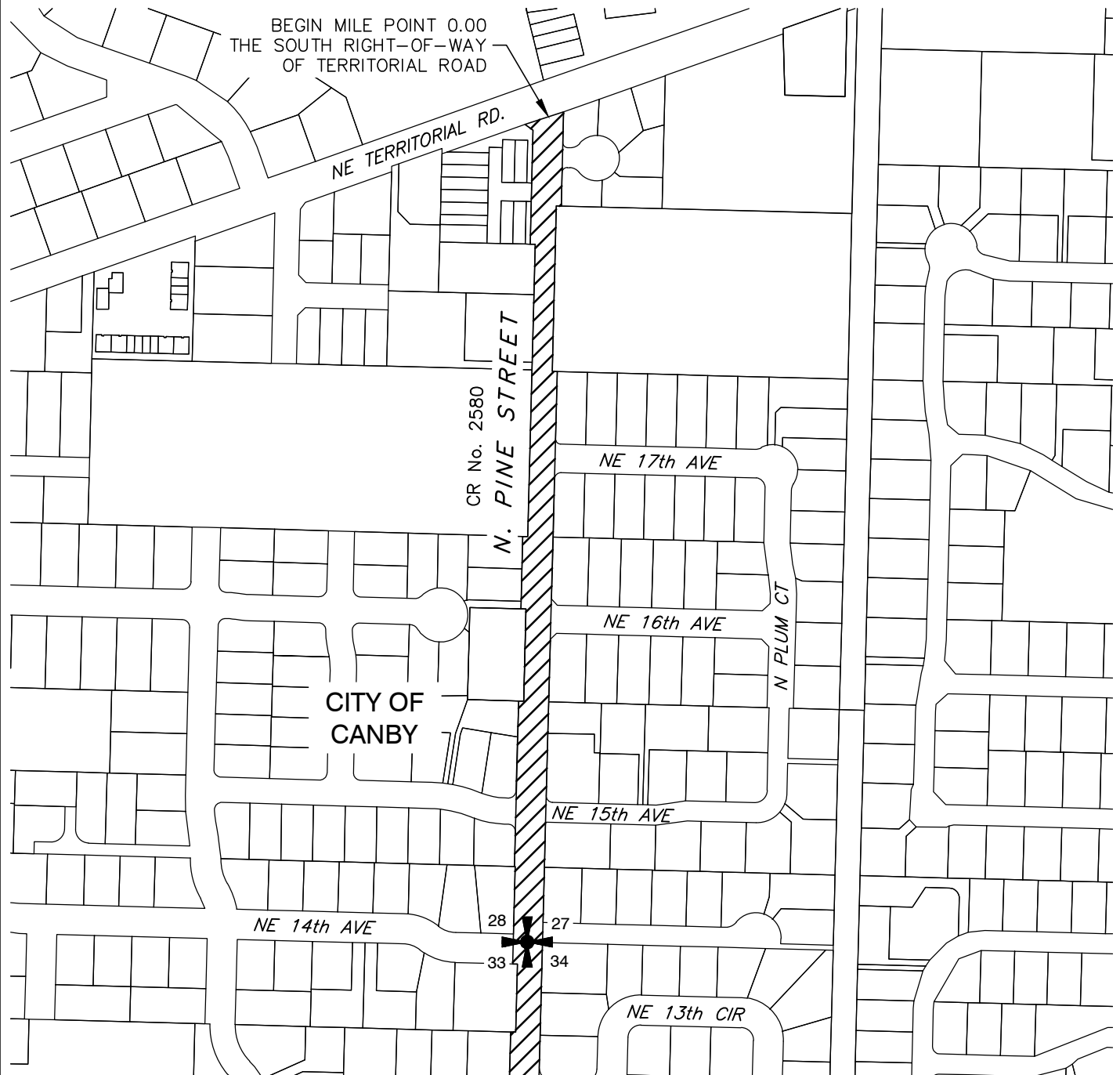

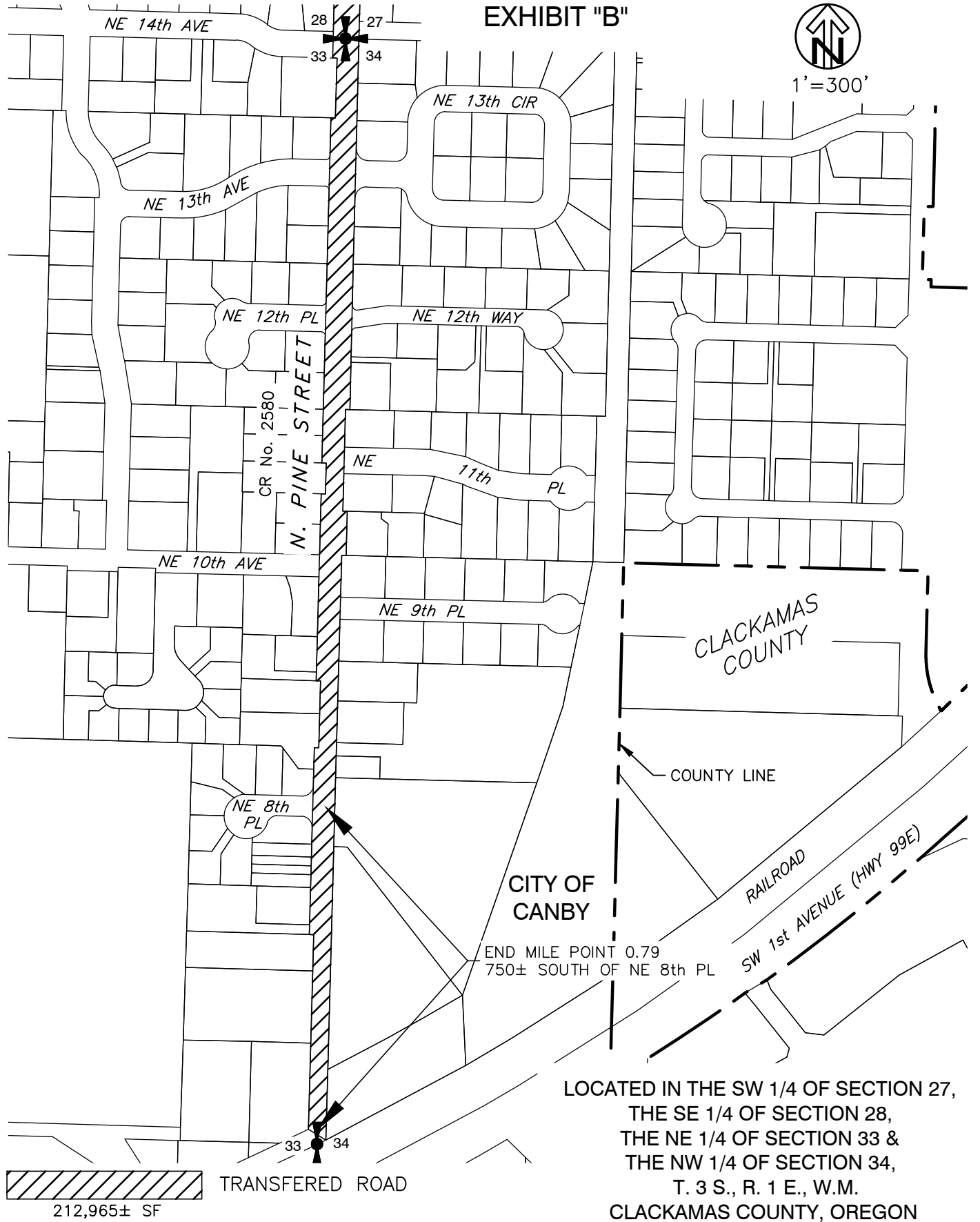

**RESOLUTION NO. 1444**

**A RESOLUTION AUTHORIZING THE INTERIM CITY ADMINISTRATOR TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH CLACKAMAS COUNTY RELATED TO THE TRANSFER OF JURISDICTION OVER A PORTION OF NORTH PINE STREET.**

**WHEREAS**, ORS 373.270 provides a mechanism for a county to surrender jurisdiction over a county road within a city to the city, provided the city requests or accepts such jurisdiction;

**WHEREAS**, North Pine Street, currently labeled as County Road No. 2580 and DTD No. 31030, is a county road, as defined in ORS 358.001;


**WHEREAS**, the portion of North Pine Street described in Exhibit "A" and depicted in Exhibit "B" attached hereto and by this reference incorporated herein ("North Pine Street") is within the jurisdictional boundary of the City of Canby; and

**WHEREAS**, the Intergovernmental Agreement provides that the City shall carry out the procedures set forth in ORS 373.270 to determine whether it is necessary, expedient, or for the best interests of the City to acquire jurisdiction over North Pine Street and, if so, to adopt appropriate municipal legislation requesting such jurisdiction.


**NOW, THEREFORE, IT IS HEREBY RESOLVED** by the City Council of the City of Canby that The City Council deems it necessary or expedient and for the best interests of the City to acquire jurisdiction over North Pine Street to the same extent as it has over other public streets and alleys of the City. The City requests the surrender of jurisdiction by the County over North Pine Street.

This resolution will take effect on October 15, 2025.
