Appointed Boards and Commissions (ABCs) Recommendation

The Committee for Community Involvement (CCI), staffed by the Department of Public and Government Affairs currently has three openings on its committee due to a term expiration. Five to nine members are allowed with four-year terms.

Recruitment opened to the public on June 26, 2026, and closed on August 15, 2026. Recruitment was conducted through Social Media, Nextdoor, the county newsletter, and the county website.

Through this recruitment process, five applications were received. One applicant was not eligible. The four eligible candidates were scheduled to be interviewed at the CCI meeting on August 18, but only one candidate attended the meeting. That candidate was interviewed and recommended for appointment. The other three candidates may be interviewed at a future meeting.

The recommendation is as follows:
