#### Appointed Boards and Commissions (ABCs) Recommendation

The Property Value Appeals Board formerly known as the Board of Property Tax Appeals, interviewed and staffed by the Clackamas County Clerk's Office, interviewed applicants for openings due to term expirations.

Board members are recruited through the community as volunteers. At least three board members are required by statute with two members forming a quorum to hold a property tax appeal hearing. We attempt to recruit enough board members to be able to operate two boards, and have alternate board members for substitutions and to gain experience. Property Value Appeals Board member terms last two years with a recent change in state statute changing Board member terms from one year to two.

In July of 2025 recruitment took place by press release on the County website and social media through PGA. Recruitment closed in August of 2025. Through this recruitment process, eight applications were received. All applicants are being recommended for selection, two as new board members while we have six board members who are applying to return. One board member is in the second year and did not need to re-apply this year. With the applicants and existing board member, PVAB will have a total of nine board members.

Per a directive from the Oregon Department of Revenue dated September 13, 1995 and pursuant to ORS 309.067, the appointments must be in writing, stating each member's name, designating which pool the member has been appointed to, the date their appointment becomes effective, and the length of their term.

We recommend the following people to the 2025-2026 and 2026-2027 Property Value Appeals Board pools. Terms would begin October 15, 2025 and end June 30, 2027:

- James Temple Recommended for Pool 1 & 2, non-office holding member, has prior experience on BoPTA/PVAB
- Richard Deich Recommended for Pool 1 & 2, non-office holding member, has prior experience on BoPTA/PVAB
- Tyler King Recommended for Pool 1 & 2, non-office holding member, has prior experience on BoPTA/PVAB




