Appointed Boards and Commissions (ABCs) Recommendation

The Historic Review Board, staffed by the Planning & Zoning Division, currently has two openings on their board due to term expirations. Seven members are allowed, each with four year terms.

Recruitment opened to the public on March 5, 2025 and closed on April 2, 2025. Notice of the recruitment was sent out by: press release, Facebook, Nextdoor, direct notice sent to CPOs, the county website, and through direct outreach from county staff. Through this recruitment process, two applications were received. One applicant is from a current member seeking reappointment, and the second is from a new applicant.

There are currently two vacant seats on the Historic Review Board. Both terms are full four-year terms expiring on April 30, 2029.

The recommendation is as follows:

*Reappoint Howard Post to a full term expiring April 30, 2029 *Appoint James Sherman to a full term expiring April 30, 2029

Howard Post is being recommended for reappointment because of his demonstrated commitment and valuable contribution as a current member of the HRB.

James Sherman is being recommended because of his experience working with the State Historic Preservation Office, his engineering work in the construction industry, and performance of historic review at the federal level.

Board of County Commissioners could reappoint both candidates or require further recruitment.
