EXECUTIVE SUMMARY: The Portland Area Security Initiative (UASI) is comprised of the City of Portland and the contiguous counties of Clackamas, Multnomah, Washington, and Columbia in Oregon and Clark County in Washington. Agencies within the UASI region may apply for the UASI grant funds.

Clackamas County was awarded the Clackamas Air Support Thermal Camera – Phase 1 project on UASI 23 for \$223,000 and Phase 2 project on UASI 24 for \$250,043.00, project total is \$473,043.00. This phased project is to procure thermal sensor systems for the Clackamas County Sheriff's Office (CCSO). The Board previously approved both grant agreements which included the phased CCSO project. The funds allocated between the two grants will cover all costs of the sensor systems in this request, for a Purchase Order of \$431,043.00. No general funds are involved.

The Board Order provides delegated limited authority to the Clackamas County Department of Finance to issue a Purchase Order (PO) to purchase the sensor systems for a total contract price of \$431,043.00.

RECOMMENDATION: Staff recommends the BCC approve the Board Order.

Whereas, the Clackamas County Board of County Commissioners (the "Board") has authority to sign all contracts and any amendments or renewals of the same;

Whereas, Clackamas County ("County") Local Contract Review Board ("LCRB") Rule C-047-0275 Sole-Source Procurements allows for County to procure items without competitive bid for the efficient utilization of goods and exchange of data with other public agencies when using mutual aid;

Whereas, the County Sheriff's Office ("CCSO") desires to purchase WESCAM MX-10 EO/IR Sensor Systems for the CCSO airplane from WESCAM USA Inc. / L3 Harris for a total contract price of \$431,043.00 ("Sensor Systems");

Whereas, the CCSO confirmed the interoperability with other local agencies for the Sensor Systems and sought a quote for the exact parts needed to maintain efficient utilization of equipment;

Whereas, the County Procurement Manager posted notice of the sole source procurement per LCRB Rule C-047-0275 (2) from September 30, 2025 through October 7, 2025 and received no protest;

Whereas, the County Department of Finance requests authority to purchase the Sensor Systems by issuance of a purchase order ("PO"); and

Whereas, a PO is issued directly through the Department of Finance's management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners resolves as follows:

1. The requested purchase of the Sensor Systems from WESCAM USA Inc. / L3 Harris in the amount of \$431,043.00, is hereby approved;
2. The Clackamas County Department of Finance is hereby delegated limited authority to issue a PO to purchase the Sensor Systems.
