Whereas, the United States General Services Administration established a cooperative contract with Datec, Inc. for the purchase of IT Solutions and Services, contract #47QTCA19D00MM (the “Cooperative Contract”);

Whereas, Clackamas County Sheriff’s Office (“CCSO”) desires to utilize the Cooperative Contract and purchase fifty Panasonic FZ-56 Toughbooks, for total of \$172,250.00, as set forth in the Datec Quote #Q26G0101, attached hereto as Exhibit A;

Whereas, the Clackamas County Department of Finance requests authority to purchase the aforementioned goods and services on behalf of CCSO by issuance of a purchase order (“PO”); and

Whereas, a PO is issued directly through the Clackamas County Department of Finance’s management software on CCSOs’ behalf with no additional signature;

NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:
