Total Agreement Value is \$200,000 for 1 year and 6 months. Funding is through TriMet Federal pass-through funds. No County General Funds are involved.

EXECUTIVE SUMMARY: The Social Services Division of the Health, Housing and Human Services Department requests approval of Amendment 1 to a Governmental Contracting Addendum with Uzurv Holdings to continue providing microtransit to meet Transportation Reaching People (TRP) ride needs. TRP provides services to seniors and individuals with disabilities who have limited or no access to public transportation. This program offers a vital link, enabling residents to access other essential resources that cater to their unique needs. This helps them maintain their independence and stay engaged in their communities for as long as possible.

Transportation Reaching People receives more ride requests than the program can support. In order to fulfil increased transportation requests, TRP received funds via TriMet to pilot an initiative with Uzurv to provide individual rides (microtransit) as needed. This pilot has been successful in reducing ride denials and enhancing service reliability. Based on this success and rate the initial funds were spent, an increase in contract value and six month term extension is necessary to meet service needs and continue supporting the TRP program.

The total amendment value is \$150,000.00. No County General Funds are involved.

RECOMMENDATION: Staff respectfully requests that the Board of County Commissioners approve Amendment 1 (12353) and authorize Chair Roberts or his designee to sign on behalf of Clackamas County.

The Purpose of this Amendment #1 is to make the following changes to the Contract:

1. Item 1, **Term** is hereby amended as follows:
The Contract termination date is hereby changed from December 31, 2026 to June 30, 2027

2. Item 2, **Consideration** is hereby amended as follows:
In consideration for Contractor performing Work during the extended term of this Contract, County shall pay Contractor an amount not to exceed \$150,000. The total Contract compensation will not exceed \$200,000.
