**EXECUTIVE SUMMARY**: The Board approved a Purchase and Sale Agreement ("PSA") and Board Order on April 24, 2025, for the acquisition of a 9.69-acre park property located at SE 70<sup>th</sup> Avenue and SE Monroe Street with Monroe Park Middle Housing LLC. The seller has requested minor revisions to the PSA to change a license to a temporary construction easement for the storage and staging of construction materials by Corpac Construction Company during the construction of the neighboring 122-unit townhome subdivision development.

This change has resulted in the PSA not being ready for signature at the April 24, 2025 Board of Directors' meeting. The attached revised Board Order seeks to further delegate signing authority to the Director of NCPRD for the completion of the PSA and all other documents necessary to complete

this transaction. The transaction involves a number of different parties and may require NCPRD to approve agreements outside of the normal process of Board review and approval.

To ensure that Board direction is adhered to the Order requires that all

**Whereas**, the Board of County Commissioners ("the Board") is the governing body of the North Clackamas Parks and Recreation District ("NCPRD"), this matter coming before the Board at this time, and it appearing that the Board has authority to sign all documents for the purchase and sale of real property; and

**Whereas**, NCPRD has proposed and the Board has previously approved a Purchase and Sale Agreement on April 24, 2025 by Board Order 2025-023 for the purchase of the property that is the subject of the Purchase and Sale Agreement with Monroe Park Middle Housing LLC for acquisition of a 9.69-acre parcel located at the intersection of SE 70th Avenue and SE Monroe Street ("Monroe Park Property"). The total purchase price is Three Million Three Hundred and Seventy-Five Thousand and 00/100 dollars (\$3,375,000).

**Whereas,** the Purchase and Sale Agreement with Monroe Park Middle Housing LLC received minor revisions since April 24, 2025, but remains in substantially similar form to the agreement presented on that date. The transaction to purchase property with Monroe Park Middle Housing LLC involves many parties, documents need to be executed on short notice, and the closing date may be re-scheduled; and

Whereas, the Board believes it is necessary to delegate limited authority to the Director of NCPRD to sign the Purchase and Sale Agreement and all subsequent closing documents, and any other documents necessary to complete the purchase of the Monroe Park Property. This limited delegation of signing authority is to ensure the timely and efficient closing of this transaction; and

# NOW THEREFORE, the Clackamas County Board of Commissioners, acting as the governing body of NCPRD, do hereby order as follows:

1. The Director of NCPRD is hereby delegated authority to sign all documents necessary to complete the Purchase and Sale Agreement and the purchase of the Monroe Park Property for the total purchase price of Three Million Three Hundred and Seventy-Five Thousand and 00/100 dollars (\$3,375,000); and

2. This delegation of signing authority requires that the Director of NCPRD to obtain review of any document to be signed by the Office of County Counsel; and
