

Appointed Boards and Commissions (ABCs) Recommendation

The Planning Commission, staffed by the Planning & Zoning Division, currently has two openings on their commission due to term expirations. Nine members are allowed with 4-year terms.

Recruitment opened to the public on February 10, 2026 and closed on March 11, 2026. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, five applications were received and two are recommended to be appointed. Three of the applicants are new, and one applicant is currently on the Planning Commission. The fifth applicant was a current member of the Planning Commission, but resigned and withdrew their application for reappointment. One new applicant failed to show up for their interview. Interviews were conducted with the other two new applicants and the remaining current member.

The recommendations are as follows:

Gerald Murphy has been a valuable member of the Planning Commission since 2018. He served two years as Planning Commission Chair and brings important insight and knowledge to the Planning Commission. Tyler King has a good understanding of the purpose and function of the Planning Commission. As a realtor and former developer, he has experience with navigating Oregon land use regulations and codes.

The Board of County Commissioners could select other candidates or require further recruitment.
