**EXECUTIVE SUMMARY**: The Clackamas County Public Health Division (CCPHD) of the Health, Housing & Human Services Department requests approval of a revenue Intergovernmental Agreement with the City of Lake Oswego for reimbursement for access to the electronic patient care records (ePCRs) software.

Clackamas County's EMS Strategic Plan, approved by the Board of County Commissioners in December 2018, identifies equipment standardization as a prioritized need. The EMS Strategic Plan Taskforce has selected electronic patient care records (ePCRs) as the first item towards standardization. Standardization of this equipment has a significant benefit for patients by ensuring coordinated, high-quality care through interoperable technology. Amendment #1 provides next year's reimbursement.

This Amendment is effective January 1, 2026, through December 31, 2026.

**RECOMMENDATION:** Staff respectfully request that the Board of County Commissioners approve Amendment #1 to the Intergovernmental Agreement (10545) and authorize Chair Roberts or his designee to sign on behalf of Clackamas County.

## **AMENDMENT #1**

## TO THE INTERGOVERNMENTAL AGREEMENT WITH CLACKAMAS COUNTY and CITY OF LAKE OSWEGO FOR ESO ePCR REIMBURSEMENT

This Amendment #1 is entered into between **City of Lake Oswego** ("Agency") and Clackamas County ("County") and shall become part of the Contract documents entered into between both parties on February 22, 2022, #10545 ("Agreement").

The Purpose of this Amendment #1 is to make the following changes to the Agreement:

- 1. Section 1, **Term** is hereby amended as follows:

  This Agreement shall be effective upon execution and shall expire upon the completion of each, and every obligation of the Parties set forth herein, or **December 31, 2026**, whichever is sooner.
- 2. Section 3, Consideration is hereby amended as follows:
  Consideration. The Agency agrees to pay County, from available and authorized funds, a sum not to exceed
  Thirty Thousand Sixty-five dollars and five cents (\$30,065.05) for accomplishing the Work required by this Agreement.
- 3. Section 4, Payment is hereby amended as follows:
