**REQUEST:** Board approval of FY26/27 Chamber of Commerce and Business Association Membership Dues for Clackamas County.

**BACKGROUND:** Each year, the Office of Economic Development (OED) proposes county membership in Chambers of Commerce and Business Associations who support economic development across the county. Dues reflect annual membership costs that vary based on each organization's renewal schedule and established fee structure.

For FY26/27, dues total \$40,277, which includes each of the Chambers in the county, as well as the four business organizations (Clackamas County Business Alliance, Greater Portland Inc, Oregon City Business Alliance and Westside Economic Alliance).

Funding is from State Lottery Dollars, which are restricted under ORS 461.540 to support activities that *further economic development*. No General Funds will be used.

Funds are included in the FY26/27 OED budget to support these expenditures should the Board authorize them.

**RECOMMENDATION:** Staff respectfully recommend the Board approve funding for the FY26/27 Chamber of Commerce and Business Association Membership Dues.
