

Appointed Boards and Commissions (ABCs) Recommendation

The District Advisory Committee (DAC), staffed by the North Clackamas Parks and Recreation District (NCPRD), currently has eight vacancies on their committee, two regular positions from term expirations, 1 from resignation, and five for newly created alternate positions. The committee is composed of eleven regular members, each serving a four-year term, and five alternate positions, one for each of the five subareas.

Recruitment was open to the public from March 30, 2026, through May 14, 2026. The recruitment effort included outreach via press releases, Facebook, Nextdoor, the NCPRD website, and the county website. A total of six applications for subareas 1-4 were received during this period. Of those, four applicants are being recommended for appointment—one as new members, one as a reappointment, and two as alternate members.

The recruitment for subarea 5 (the position being filled by Sasha Grenier) was completed by the City of Milwaukie. Through the City's recruitment process, one applicant was recommended to be appointed as an alternate.
