EXECUTIVE SUMMARY: On 7/15/25 Board authorized staff to apply for a Business Oregon Special Public Works Fund (SPFW) loan to assist with financing of the Clackamas County Fair & Event Center multiuse building project.

Business Oregon offers low interest loans to public agencies for projects through the SPFW. To identify if this project meets loan guidelines, staff completed a required Business Oregon Intake Form for consideration of approval to apply for the SPFW low interest loan. Business Oregon confirmed this project meets their lending criteria and extended an invitation on June 4, 2025 to apply for the loan. The County had been given 45 days, a deadline of Friday, July 18, 2025, in which to apply for the loan.

Due to timing, County Administrator Gary Schmidt was required to sign on behalf of the County in order to meet the application deadline of July 18, 2025.

Due to the unique nature of this loan, current County ordinance allows Administrator Schmidt to sign on behalf of the Board for various purposes but does not specifically mention loans.

This ratification will provide necessary documentation that the Board acknowledged and approved Administrator Schmidt's authority to sign the Business Oregon loan application.

County Counsel reviewed and approved signing of the application.

Opportunity/Problem

Briefly describe the opportunity or problem facing the applicant:

This new 43,000 square foot facility is a replacement for the 1924 Livestock Barn that received major damage from a 2011 snow storm, and was subsequently deemed unsafe and deconstructed in 2014.

This flexible, all-season facility was designed to serve a wide range of public uses (including, but not limited to: exhibitions, conferences, educational programming, community gatherings, and emergency response support.)

Response to Opportunity/Problem

Briefly describe the major alternatives considered to address this opportunity or problem: A temporary tent structure had been errected on site and used for events and emergency evacuations, but was only temporary as it could not accommodate safely the people and live stock that used the facility.

Built with durable infrastructure and modern amenities, the building enhances the Fair's ability to host year-round events while also serving as a critical community resiliency resource.

Detailed Project Description

Clearly describe the proposed project work to be accomplished:

Construction of a new 43,000 square foot multipurpose event center that can accommodate live events, meetings, live stock shows, and tourism related activites.

In times of crisis, it can be activated as a reunification site, shelter, mass vaccination site or emergency operations hub—providing a safe, accessible, and dependable space for residents of Clackamas County and surrounding areas. The new multipurpose building at the Clackamas County Fairgrounds has been formally identified as a critical asset in the county's emergency preparedness and community resiliency planning.

If the Board of County Commissioners declares any emergency, the Center and all fairground facilities will be called into use. This could include; fire related evacuations, vaccine clinics and any other unforeseen emergencies that require the safe gathering and/or housing of people and livestock.

A small low interest loan is needed to fill the gap of funding that has already been commtted to build the structure.
