DATE: June 17, 2025

**REQUEST:** Approval of non-competitive arts grant funding requests for FY25/26.

**BACKGROUND:** Each year, the Office of Economic Development (OED) provides the Board of County Commissioners with a list of funding requests for non-competitive grants traditionally awarded to arts, cultural, and educational nonprofit organizations.

For the FY25/26 funding cycle, OED has received funding requests from the Clackamas County Historical Society (Museum of the Oregon Territory – MOOT), and the Clackamas County Arts Alliance (CCAA).

The requests are:

- Clackamas County Arts Alliance (CCAA) \$125,000
- Clackamas County Historical Society (Museum of the Oregon Territory MOOT) \$125,000

Last year, a pilot program was funded with the Clackamas County Cultural Coalition. Because they are currently in the grant funding process and have no results to share to support return on investment, they have not been included for the purpose of this discussion.

Funding for these non-competitive grants is from State Lottery Dollars, which are restricted under **ORS 461.540** to support activities that *further economic development*. No General Funds will be used.

"Furthering economic development" includes, but is not limited to, providing:

- (A) Services or financial assistance to for-profit and nonprofit businesses located or to be located in Oregon;
- (B) Services or financial assistance to business or industry associations to promote, expand or prevent the decline of their businesses; or
- (C) Services or financial assistance for facilities, physical environments or development projects, as defined in ORS 285B.410 (Definitions for ORS 285B.410 to 285B.482), that benefit Oregon's

economy. [1985 c.302 §7(7); 1995 c.12 §7; 2002 s.s.3 c.6 §18; 2005 c.835 §27; 2009 c.872 §3;

2011 c.699 §8]

Similar to last fiscal year, funding the requests at amounts slightly lower than requested-\$110,000 to the Clackamas County Arts Alliance and \$100,000 for Clackamas County Historical Society--would preserve funds and maximize their use to further economic development in more areas of Clackamas County.

Funds are earmarked in the FY 25/26 budget to fund these expenditures should the Board authorize. The Office of Economic Development is funded primarily through annual Lottery Funding provided by the State of Oregon that is statutorily required to be expended for Economic Development activities. In FY 25/26 Lottery Fund revenue is estimated at \$2,750,500 and programmatic reserves are estimated at \$6,706,888. Reserve funding is being held to support future economic program expenditures and personnel costs in future years.

**RECOMMENDATION:** Staff recommends the Board approve funding in the amount of \$110,000 for the Clackamas County Arts Alliance and \$100,000 for the Clackamas County Historical Society.

Laura,

We are requesting \$125,000 in funding from Clackamas County for the July 2025 to June 2026 fiscal year to support our mission to **collect**, **preserve**, **and share the culture and history of Clackamas County**. This funding will enable us to continue offering high-quality educational programming, install new exhibits, preserve collections, and maintain the facilities that serve as vital community gathering spaces.

### Strategic Priorities for FY 2025-2026

In the coming fiscal year, we aim to expand our reach and deepen our impact through the following core initiatives:

- Develop and deliver dynamic K-12 and family education programs inspired by our new exhibits, in collaboration with schools and community partners.
- Share our history through the installation of two major exhibits to engage the public with compelling local stories and historical themes: Jennings Lodge Camp: A Gathering Place for Faith, Community, and Revival and the Willamette River: Land, Culture, and History.
- Preserve and care for over 36,000 artifacts in our collection to ensure future generations can learn from and enjoy them.
- Enhance the Stevens-Crawford Heritage House grounds to increase community event offerings and expand opportunities for earned income through rentals.
- Ensure safe, accessible, and welcoming facilities for all visitors through routine and critical maintenance.

#### **Building on our Success**

Since 2022, Clackamas County support has played a pivotal role in expanding our educational outreach and visitor engagement. Highlights include:

- A **dramatic increase in school engagement**, with our 4<sup>th</sup> and 5<sup>th</sup> grade history program growing from zero to over 1,000 student participants in just two years.
- **Collaborative programming** with two other historic sites, Ermatinger House and the McLoughlin House, reaching underserved students and first-time museum visitors.
- **Broadening access** to county history beyond our physical locations. We are reaching audiences through our website with a new online exhibit on Jennings Lodge Camp to add to our two online exhibits: *She Flies with Her Own Wings* and *Life & Death in the Oregon Territory*.

#### **Use of Requested Funds**

County funding will directly support our mission in the following ways:

### **Education and Public Programs**

- Supplies for school and family programs to support the new *Jennings Lodge Camp* and *Willamette River Exhibits*: **\$1,800**.
- Background checks for new education and collections volunteers: \$700.
- Professional memberships to stay current with museum best practices: \$500.

# **Staffing Support**

- Partial salary support for Zack Lynch, our .75 FTE Visitor and Volunteer Engagement Coordinator, who coordinates in-person education programs (\$18,240 62% of salary).
- Partial salary support for Waldo McGinnis, our **.75 FTE Web and Print Media Specialist**, who manages digital outreach, marketing, and visibility (\$20,160 62% of salary).

#### **Collections and Preservation**

Archival supplies to preserve our collection of over 36,000 items: \$7,000.
 Archival supplies are critical to protecting our collections from deterioration. The County funding will assist with preserving our collections through the purchase of supplies to maintain our collection of over 36,000 accessioned items. The funding will make our collections and historic photos available to researchers and the public by renewing our subscription to CatalogIt - an application that empowers users to discover interconnected stories from Clackamas County.

### **Exhibits and Facility Maintenance**

To support our upcoming exhibits (May and September 2025 installations), we must ensure that our facilities are safe, functional, and welcoming. Funding will cover essential building maintenance, including:

- Replacement of aging heat pump: \$20,000.
- Groundskeeping: \$1,600.
- Wood floor refinishing: \$6,000.
- Elevator maintenance and inspection: \$1,000.
- Gutter cleaning: \$2,000.
- Janitorial services: \$5,100.
- Building security: \$2,000.
- Facilities equipment: \$2,300.

## **Operational Support**

Vital day-to-day costs required to keep our museums open and accessible:

- Utilities: \$30,000.
- Postage and mailing: \$500.
- Printing and copying: \$2,000.
- Office expenses: \$500.
- Telephone, DSL, and Tech. expenses: \$3,600.

# **Our Impact and Vision**

Our museums are vital storytellers of how Clackamas County has grown, adapted, and transformed—from the deep roots of Indigenous cultures and the journeys along the Oregon Trail to the technological innovations powered by the Willamette Falls. This is Oregon's most richly layered history, and it lives here. Through immersive exhibits and educational programs, we illuminate the lives, struggles, and achievements of everyday people—offering visitors of all ages a deeper understanding of the present through the lens of the past.

We are honored to steward this legacy. With Clackamas County's continued investment, we will ensure that these stories remain not only preserved but powerfully shared—accessible to all, relevant to our times, and inspiring for generations to come.

## **Request for Funding**

Laura Edmonds, Economic Development Manager and Clackamas County Board of Commissioners

We are requesting a grant of \$125,000 to support our work throughout Clackamas County.

The mission of the Clackamas County Arts Alliance (Arts Alliance) is to keep arts and culture central to life in Clackamas County. As an arts services organization, we champion a vibrant, creative, and connected way of life in the County's urban and rural communities by advocating for, promoting, and facilitating access to all forms of arts and culture. We are a partner and a resource for organizations and individuals contributing to the vitality of the places and spaces we live, work, learn, and play. The Arts Alliance serves as the chief resource for five arts commissions, eight guilds, 13 libraries, 35 museums, and hundreds of artists, makers, writers, performers, creative entrepreneurs, businesses, and educators. We are also the fiscal agent for the Clackamas County Cultural Coalition.

This year, our relationship with the county expanded with the Arts Alliance advising and facilitating the public art plan for the new Clackamas County Courthouse. We served as the fiscal sponsor for philanthropically supported art projects to be exhibited in the courthouse.

#### History:

Appointed in 1994 by the Board of Commissioners to advise and advocate for the arts in Clackamas County, the Alliance has evolved from an all-volunteer advisory board (originally called the Arts Action Alliance) to an independent 503 (c)(3) nonprofit. Our professional staff is acknowledged as the "go to" for information about local arts activities, funding opportunities, and representation with local, county, regional, and statewide initiatives. The County and the Arts Alliance's long history has been beneficial and supportive to all residents living and visiting the area.

#### 2025-2026 Focus:

The Clackamas County Arts Alliance is an impact multiplier. As a convener, the Arts Alliance brings artists and creatives together to learn and share. As an advocate, we leverage the arts and culture as an economic driver and educate local governments and businesses on the value of investing in a vibrant creative community. As a partner, we promote a wide range of activities and opportunities to a broad community. As a collaborator for more than 20 years, the Arts Alliance is a resource for anyone contributing to or interested in arts and culture in Clackamas County.

The Arts Alliance programming in 2025-2026 is focused on facilitating promotional and financial opportunities for arts organizations and individual artists to reinforce their operations and/or grow their business potential. The County's continued funding will allow:

- Discovering new spaces and innovative venues where the work of Clackamas County artists of all genres and mediums can be displayed and sold.
- Increasing rural outreach and establishing new cultural alliances and community-based partnerships.
- Collaborating with underrepresented artists and makers to increase their public profile and expand access to opportunities.
- Galvanizing a coalition of artists and makers committed to expressing a broad range of deeply rooted cultural traditions and elevating Vintage, Folk, and Heritage artists and makers to enrich Clackamas County's cultural fabric.
- Creating channels for artists and makers to acquire business skills, explore professional development, and contribute meaningfully to Clackamas County's vibrant arts and culture community. Engage presenters and coaches to develop and present professional development curriculum for artists and makers.
- Champion economic development opportunities that benefit artists and makers as well as local communities.

### **Request:**

We are requesting funding of \$125,000 for the next fiscal year to support the Arts Alliance's ongoing work and the new economic initiatives described above. I would be happy to answer any questions you may have or provide additional information.

In 2024, Clackamas County Arts Alliance embraced our role as convener, collaborator, and champion for arts and culture as never before. We listened to local creatives and creators, strengthened connections in urban and rural communities, and promoted cultural tourism. We advocated for investment in the people, organizations, and activities that represent Clackamas County's unique cultural identity and we forged partnerships to sustain and grow arts and culture for future generations.

**A HUB FOR ARTS & CULTURE** | As an arts services organization, the Arts Alliance is the chief resource for eight arts commissions, three guilds, 13 libraries, 35 museums, and hundreds of artists, writers, performers, creative entrepreneurs, businesses, and educators. We are the fiscal agent for the Clackamas County Cultural Coalition, which distributes Oregon Cultural Trust funds to more than 75 local arts, history, heritage, humanities organizations, and cultural creatives.

A BROAD REACH | The Arts Alliance is a centralized source for two-way information sharing. On our website (www.clackamasartsalliance.org), community members can look for the latest news and information about arts and cultural activities in Clackamas County. We maintain a monthly calendar that can be sorted by interest areas, location, and other signifiers. Arts organizations and individuals can post information and also access opportunities such as trainings or funding availability. The Arts Alliance is an impact multiplier, distributing information through our electronic newsletter and emails blasts and posting the latest happenings on our social media platforms. In 2024:

- Our website had 53,000+ views (increased from 39k in 2023) and more than 17,000 active users
- We connected with 1,500+ Instagram followers and had a reach of 4,600 (up 34% from last year)
- 1,717 users subscribe to our email list
- 240+ events were submitted to our website calendar
- 50+ opportunities were submitted to our website, including grant postings, public calls to artists, auditions, jobs, and more

The Arts Alliance makes more visibility possible for the arts and culture community and builds direct connections with anyone interested in engaging in all that Clackamas County has to offer.

A COORDINATOR OF OPPORTUNITIES | With the addition of a Community Outreach and Engagement Manager in 2024, the Arts Alliance was able to spend significantly more time out in the community making personal connections with individuals, organizations, and businesses committed to a dynamic arts and culture landscape. Personal visits, tabling at arts events, and other outreach activities allowed us to familiarize members of the Clackamas County arts and culture community with the many tools available to them through the Arts Alliance. We made

meaningful connections with countless artists and creatives, including those not currently engaged with the Arts Alliance, senior artists exploring a new creative life chapter, and artists with disabilities interested in more opportunities to share their work. Many are attending our workshops and trainings, which is giving them a place to learn, explore, grow their art, and build community.

A PROMOTER OF ECONOMIC VITALITY | In addition to attracting visitors to arts and culture events and supporting artists and organizations in their pursuit of prosperity through creativity, the Arts Alliance is a regular collaborating partner in important cultural initiatives. Currently, the Arts Alliance is the fiscal agent and public art facilitator for Clackamas County's new courthouse, as well as the fiscal agent for the transformation of Milwaukie's historic City Hall building into a new community gathering place where local art will be a focal point. The Arts Alliance continues to share valuable data from the "Arts and Economic Prosperity Study," highlighting the ways in which the arts serve as an economic driver as well as a community benefit.

A BUILDER OF NETWORKS | In the past year, the Arts Alliance reached out to more than 250 theatres, libraries, visual arts studios, galleries, schools, literary events, festivals, and music organizations. Our Community Outreach & Engagement Manager acted as a liaison with eight different arts and culture commissions or committees, as well as three artists guilds to build relationships and learn more about the activities and artists in their area. We attended meetings and provided resources, guidance, and support for the communities of Estacada, Happy Valley, Lake Oswego, Milwaukie, Molalla, Oregon City, West Linn, and Wilsonville, as well as Three Rivers Artists' Guild, North Clackamas Artists Guild, and Wy'East Artisans' Guild, among others.

A RESOURCE FOR LEARNING & BUSINESS DEVELOPMENT | The Arts Alliance developed and hosted a new series of workshops for artists and makers from Clackamas County, where participants explored business potential and creative opportunities. Our focus was to reach artists and makers looking to elevate their current business model or transform a creative passion into a profitable venture. Workshop themes included:

- Formulating a Business Plan
- Pricing Your Creative Work
- Marketing Your art and Creative Business
- Self-Publishing Your Writing
- Building a Website and Online Store
- Legal Assistance for Artists Including Copyright Law

With these workshops, our goal is to serve as a business incubator for beginning creative entrepreneurs and help artists, writers, and makers (including small-batch manufacturers) create viable sidelines and small businesses. Participants are able to learn from each other and hear success stories from other artists and makers. Connections are also made with organizations that support small businesses.

A FACILITATOR OF ART EXHIBITIONS | The Arts Alliance matches artists with libraries, hospitals, county buildings, and other public spaces so their art can be viewed by the public. We coordinated installations and artwork rotations in galleries and other venues throughout Clackamas County, where community members were able to enjoy changing exhibits, experience various art mediums, and learn about local artists. In the past year, the Arts Alliance's long-standing Artist Exhibit Program (AEP) hosted 66 gallery art installations exhibiting 119 artists with 613 artworks. About half of the participating artists in 2024 were new to the program. Participation in AEP opens doors to additional exhibit and sales opportunities for

the more than 200 artists on our roster, while also providing skill building and gallery readiness training.

A VOICE FOR CLACKAMAS COUNTY'S CREATIVE COMMUNITY | The Arts Alliance represents Clackamas County in the ongoing planning and implementation of "Our Creative Futures", an arts and culture blueprint for the tri-county region. The plan envisions a tri-county region where everyone has access to relevant and dynamic arts, culture, and creative experiences as an essential part of our lives. Our Executive Director continues to work side-by-side with Clackamas County staff and representatives to ensure that a robust arts and culture community remains a priority for public funding and tourism endorsement.

A PLACE TO SHARE & ENGAGE | The Arts Alliance regularly invites the public to explore all that Clackamas County has to offer through regular distribution of e-bulletins noting upcoming activities. Our website provides a month-by-month calendar that promotes hundreds of events and experiences throughout the year. We also have an "Opportunities" page that posts calls for artists, job announcements, contests, potential grant applications, funding prospects, and other information relevant to the creative community.

A VISION FOR THE FUTURE | With a mission to keep arts and culture central to life in Clackamas County, the Arts Alliance will continue in our role as a centralized convener engaging with various stakeholders, identifying shared goals, encouraging the expression of ideas, and spurring action on behalf of the arts and culture community. Plans for 2025 include:

- Building upon our successful Artist Exhibition Program by discovering new spaces and innovative venues where the work of Clackamas County artists of all genres and mediums can be displayed and sold.
- Connecting with artists and makers in rural communities through increased outreach and establishing new cultural alliances and community-based partnerships that expand opportunities throughout the county.
- Fostering cultural equity by identifying and working with underrepresented artists and makers to help them increase their public profile and access pathways for showcasing and marketing their work.
- Creating safe spaces for community building and offering welcoming experiences that reflect and celebrate the cultural, racial, gender, age, and abilities diversity that exists in Clackamas County.
- Promoting diversity in creative expression by formalizing a coalition of makers and creatives committed to the production of Vintage, Folk, and Heritage Art that expresses a broad range of deeply rooted cultural traditions.
- Supporting economic mobility by providing workshops, training, and networking
  opportunities for artists and makers to acquire business skills, explore professional
  development, and contribute meaningfully to Clackamas County's vibrant arts and
  culture community.

**SOMETHING FOR EVERYONE** | Tens of thousands of children and adults had the opportunity to connect with arts and culture in Clackamas County in 2024. Here is a small sampling of events and activities promoted by the Clackamas County Arts Alliance:

Literature & Reading: Library reading programs, author lectures, and special activities for children and adults were publicized, along with the Oregon City Writers Group, Literary Arts' Annual Writing Contest, and Milwaukie Ledding Library's Fall Author Series featuring writers such as Deborah Jackson Taffa, a citizen of the Quechan (Yuma) Nation and Laguna Pueblo.

Festivals & Gatherings: Dozens of events showcased Clackamas County's unique cultural landscape, including the Celebrate Molalla Community Festival, Sandy's Hispanic Heritage Celebration, Milwaukie's Bing in the New Year with Chinese cultural performances celebrating the birthplace of the Bing cherry, and the Oregon City Festival of the Arts.

*Music:* Music of all kinds could be heard at Youth Music Program's "Teen Open Mic Night" in West Linn, Tilikum Chamber Orchestra's Fall Concert in Lake Oswego, "Opera al a Carte" at Molalla's Music in the Park Series, and Chapel Theatre and Stageworks Ink's presentation of "FLASH AH-AHHHH!" Rock Operetta in Milwaukie.

Theatre: From musicals to movies, audiences enjoyed "Mary Poppins" presented by Oregon City Children's Theatre, Sandy Actor's Theatre's production of "Aboveboard", B.A.M. Movie Matinees designed for our Disability Community, Lakewood Theatre's "Jersey Boys", and "My Fair Lady" at Clackamas Repertory Theatre.

Galleries & Exhibitions: Events throughout the county featured local artists at events like Plein Air Painting in Wilsonville, Gladstone's Brush and Palette Art Association Show and Sale, Basil & Art Festival in Canby, First Fridays at the Spiral Gallery in Estacada, and rotating exhibits at Lake Oswego's Artspace, featuring work by artists such as photographer Akihiko Miyoshi.

Heritage Experiences: Engineering innovations designed and used by First Nations in Oregon were showcased at Sandy Public Library, fiber artists joined other handcrafters at an informal Fiber Arts Circle in Sandy, and the Yarn Enthusiasts Society hosted a meetup in Oregon City.
