EXECUTIVE SUMMARY:

The Department of Transportation and Development, Transportation Maintenance Program has requested that Clackamas County Fleet Services purchase one (1) new current model year Case Farmall 110A tractor with Tiger Mowers Extreme Duty side flail mower. This mower is a direct replacement for an older mower that has reached the end of its useful life.

PROCUREMENT PROCESS:

Approval of the purchase is being requested under the Local Contract Review Board Rule C-046-0400, Authority of Cooperative Procurements. The purchase will be made using Sourcewell contract #070821-TGR with Tiger Mower.

RECOMMENDATION: Staff respectfully recommends the Board approve this purchase and authorizes Procurement staff to issue the PO on behalf of the County.

Whereas, the Clackamas County Board of County Commissioners (the “Board”) has authority to sign all contracts and any amendments or renewals of the same;

Whereas, Oregon Revised Statutes (“ORS”) Chapter 279A.200-220 and Local Contract Review Board Rule C-046-0400 permit Clackamas County to purchase goods or services using a cooperative procurement;

Whereas, Sourcewell established a cooperative contract #070821-TGR (“Sourcewell Contract”) with Tiger Mowers for the purchase of Case Farmall 110A tractor with Tiger extreme duty side-flail mower installed;

Whereas, the Clackamas County Department of Transportation and Development desires to purchase one (1) new current model year Case Farmall 110A tractor with Tiger extreme duty side-flail mower installed (“Tractor”) through the Sourcewell Contract for a total contract price of \$151,858.00;

Whereas, the Clackamas County Department of Finance requests authority to utilize the Sourcewell Contract to purchase the Tractor by issuance of a purchase order (“PO”);

Whereas, a PO is issued directly through the Department of Finance’s management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners resolves as follows:

1. The requested use of the Sourcewell Contract to purchase the Tractor in the amount of \$151,858.00 is hereby approved;
2. The Clackamas County Department of Finance is hereby delegated limited authority to issue a PO to purchase the Tractor using the Sourcewell Contract.
